This island is a family attraction for those who can afford it and its name has the letter B in it. An older man with thinning white hair and glasses is involved in the drug process. He is standing in a library with shelved books and a globe in a small house structure. Although the bulk of drugs can be found in this main structure, some can be found beneath the floor in the back of a plain white van which is utilized for transporting the contraband. The pure substance is in small grey/blue plastic tub conatiners and is transported in brown cardboard boxes. Another structure is to the left and is hexagon shaped with tinted rectangular windows. Tennis courts can be found further south in this area. See attached sketches.
