SUBJECT: SUN STREAK Report - Third Quarter CY 89 (U)

TO: Chief Scientist, DIA

1. (S/SK/WNINTEL) In pursuance of SUN STREAK's operational intelligence mission, the following reports reflect the results of activity pursued by the Prototype Operational Group (POG) for the reporting period:

a. (U) At TAB A is the Quarterly Production Report as sorted by viewer.

b. (U) At TAB B is the Quarterly Production Report as sorted by project.

c. (U) At TAB C is the Quarterly Production Report as sorted by remote viewing operational methodology.

At TAB D are the results of a training effort pursued by the POG under the auspices of SRI. This effort is being pursued on a weekly basis. Unclassified results in the form of summaries are mailed to SRI. Receipt of SRI feedback is anticipated for the near future. The conduct of "beacon" training searches will continue as time permits.
