SUBJECT: SUN STREAK Report - First Quarter CY 89 (U)

TO: Chief Scientist, DIA

1. (S/SK/WNINTEL) In pursuance of SUN STREAK's operational intelligence mission, the following reports reflect the results of activity pursued by the Prototype Operational Group (POG) for the reporting period:

a. (U) At TAB A is the Quarterly Production Report as sorted by viewer.

b. (U) At TAB B is the Quarterly Production Report as sorted by project.

c. (U) At TAB C is the Quarterly Production Report as sorted by remote viewing operational methodology.

2. (S/SK/WNINTEL) In late December 1988, [redacted] was reassigned from the POG to the Systems Evaluation Detachment (SED) of the US Army Intelligence Agency (USAIA). No suitable replacement has been found to date.

3. (S/SK/WNINTEL) It is anticipated that [redacted] will complete Stage VI of his Coordinate Remote Viewing (CRV) training in late April 1989. [redacted] is currently undergoing Extended Remote Viewing (ERV) training which is projected for completion in late May 1989. [redacted] continues to develop her ability in Written Remote Viewing (WRV) under the tutelage of [redacted]. Results obtained by [redacted] to date are encouraging in view of the correlation obtained with findings from other remote viewers.

[REDACTED] are enrolled at the Defense Intelligence College in pursuit of career related training. Both will attend classes Wednesday afternoons during the second quarter, CY '89. [REDACTED] is currently enrolled in an advanced ADP programming class meeting every Thursday at the Defense Intelligence College.

[REDACTED] continue to attend monthly classes on dowsing. From 31 March 1989 to 2 April 1989 inclusively, [REDACTED] attended a three-day seminar presented by the Discovery Engineering International (DEI) in the Washington D.C. area. Through tonal indicators, they were able to achieve a state of relaxation at the theta level of consciousness that appears to facilitate personal creative breakthroughs. A tonal indicator was utilized as a sort of beacon to recognize and remember the theta state of consciousness.

4. (S/SK/WNINTEL) Search problems are being added as a last step to ongoing projects to allow remote viewers an opportunity to develop and enhance their skills to a marketable level while operating in a search mode.

5. (S/SK/WNINTEL) During the conduct of a topical search, [REDACTED] phonetically surfaced the name of a Libyan freighter projected to load chemicals from the Port of Tripoli. The vessel reportedly dumped its load of chemicals in the Mediterranean Sea and sailed to Italy. The results of efforts to confirm the presence of chemical compounds aboard the vessel are unknown. Results of sessions conducted against Flight 103 are being assessed with results of investigation published through the public media.
