Summary of to find

The target is ~~now~~ currently located at $23^{\circ} 27' N$ $89^{\circ} 22' W$. The vessel is concerned with evading detection. It is transporting narcotics, which are located in one of two areas. The key to finding the contraband is an area where metal shavings / filings occur. Sense that something has been injected into the center mast and that the mast is considered expendable. It is to be cut in half. The injected material is white and dense. ~~The search area~~

If this is the location of the contraband, metal shavings are found around the ^{deck} base collar of the mast. The search area on the vessel is associated ~~with~~ in the rear ^{part of} the vessel near the engine. ^{A section of the part} The ~~two~~ part of the part side wall of this area has been packed by solid and dense ^{heavy} nylon bags in between the ~~struts~~ struts or ribs. The section containing the packages is very solid. If this is the location, metal shavings will be found at the base of this specific wall section.

Sense that a primary person (a man) on board is not aware what is on board. of what the vessel is actually carrying. A [name] man in Harrisburg PA is associated with this target in some way.
