- 2. (S-SS) Cuing: None. The following were spontaneous impressions which occurred without cueing.
- 3. (S-SS) Results: The site is an armored car robbery in a large American city.
- a. The armored car was perceived partially up on the curb in front of a store on a "downtown residential" street. That is, in one of the sections of a large city which is well within the downtown, but still has people living there, as well as stores, shops, etc. The armored car appeared to be an off-green color, possibly olive drab. The driver of the car was slumped backward and to the side in the driver's seat. He had blood on his face and the side of his head. I think he was dead. I did not see any other uniformed personnel.
- b. The door of the car was open and there were a few small ingots of silver colored metal lying on the ground beside a bent "badge-shaped" metal insignia of some type. I had the impression of "Treasury Department" when I saw it. The ingots were there for the taking. I was impressed by the fact that the ingots appeared to be all of the same color, but that they seemed to have various shapes, and various numbers stamped into their top sides. The number's were simple (not like serial numbers, but like weights).
- c. The incident had already happened when I perceived it, but I had the strong impression that it could have been stopped, if anyone had known it was going to happen. It must have happened during the night, or the early morning hours, because the stores along the street were not open yet.

- d. (The following is an explanation of the accompanying sketch)
- 1) The store in front of the car had a vacant lot on the "away from downtown" side of it, and a street came into the street from an angled direction.
- 2) Quite a way down the street, headed in a downtown direction, there was a large vacant "field" on the left hand side of the street.
- 3) Further, there were stores on both sides of the street, with side indentations in the curbs, where people waited for busses.
- 4) A bit further, there was a closed, almostblock-long side street which was very wide, with a center island, and was surrounded by tall buildings. Traffic could enter one side of this area and leave through the other side. The area had many parking meters. There was a policeman standing, talking to a man here. The policeman's uniform consisted of a grey shirt and black pants. He also had insignias on his upper sleeve, and a metallic badge on his pocket.
- 5) Only a few blocks further, the street crossed the major streets of the city. These appeared to be large, one-way streets. There were several of them, with heavy traffic. The street on which the robbery occurred was crowded, but not a major thoroughfare.
