(S/NF/SK) MISSION: Correctly acquire and describe the major gestalts (stage 1 phase two) of the site, St. Tropez, France, training site 1012.

- 2. (S/NF/SK) VIEWER TASKING: Coordinates 1012/ 8705.
- (S/NF/SK) COMMENTS: Viewer reported an physical inclemency of chlorine eyes. After the second ideogram (first ideogram was a miss break) the viewer asked me if the site was a city by the water. I told her I couldn't answer and to disregard that as AOL. After the viewer decoded numerous site gestalts correctly I declared "site" as it was apparent the viewer was beginning to bilocate. To minimize the frustration she had experienced earlier (see 880515 morning session) I allowed her to continue to view and sketch what she was perceiving. The sketch is attached to the session. While sketching she described the site as being shaped like a cove with the a rocky beach with pebbles and rocks of several sizes, with colors of brown, orange, black and gray.
- 4. (S/NF/SK) EVALUATION: Viewer correctly decoded five of the site gestalts land, hill, sand, water, rocks. Her structure was excellent: I/A/B sequences and AOLs objectified correctly in format. Viewer also probed above and below the ideograms to check for additional A/B pairs. She again voiced difficulty in distinguishing between water and motion, though on the second

ideogram with a feeling of motion the B of water came through strongly and was not simply an assumption on her part that because it was motion it was water (an assumption she made in the past). Viewer mentioned after the session (even though she did not get an ideogram for a structure) that she feels that she still does not have the feeling for man-made. She said that she can easily tell if something is natural and that since she hasn't been able to sense man-made she checks each ideogram to see whether it is "natural" or not. Recommend that other S1 sites containing structure gestalts be given.
