Viewer successfully coped with voice interference from an ongoing lecture in the adjoining room; and coped equally well with the departure of a third person in the room. The departure was prompted by an urge to cough. Viewer ended the session by accessing Area "B"; Area "B" will serve as a point of departure for the fourth, and probably, last session conducted against this training target.


VIEWER 95 30 MARCH 1988 START 1430 END 1525 ERV TRAINING


Session was a continuation of the one on A March 1988. The session began with an overhead view of the general site. Again it was highly patterned ground. There was again the feeling of paths, yet also the feeling of city. One area was patterned in a series of concentric rectangles. While viewing this area I experienced an AOL of the Mall in Washington, DC.

Structure A was a big large stone structure with stairs leading up. Inside was a large, open, high ceilinged room "like an arena or a theater". The room was filled with tourists watching. The people that worked there were entertaining. One was very serious and wore a formal, dark suit; he was in charge. A woman who worked there was dressed in a small flimsy garment AOL like a ballerina. She seemed to work alone in the air (AOL: trapeze artist). At one point she was spinning upright a few feet above the ground. I had an AOL/S of the circus, so I went to look at the walls again and they were solid, hard, smooth, cool as described in the last session. The people watching were in awe and happy. The general feeling of the place (area A in its entirety not just the structure) was that of a park. I kept getting strong images of people walking cheerfully along paths.

Area B was a large defined area of ground/path AOL like a race track. The structure in area B was tall and slanted on one side. This caused immediate AOLs of stadium/coliseum. The AOLs were so strong I requested a break and the session ended.
