Summary

Site is <sup>large</sup> underground structure w/ balcon, a cat walk & large rectangular container <sup>on bottom</sup> <sup>or change</sup> thick sides, containing fluid / water & rows of rounded objects inside. Condition of objects is continually monitored & regulated. Objects are regularly removed, packed w/ others (protective equipment must be used) & distributed. Objects contain granular, speckled material which can't be removed, by hand, but must be removed by some ~~last~~ intervening device. Strong impressions of nuclear relatedness w/ AEC's & reactors, etc. involved.

One individual in a white, heavy duty protective - type suit (AEC's <sup>Asbestos suit</sup> w/ gloves + hood + face plate) was observed. He was a technician, performing general routine activities. He reported to a supervisor elsewhere when unusual conditions arose or "parameters numbers" had to be changed. Supervisor in turn <sup>was responsible for</sup> ~~was responsible for~~ a superior elsewhere who may ~~have been~~ wear a uniform of awards & insignia (see pp. 11-12)
