1. (S/NF/SK) Tasking: (Initial tasking data attached). Additional instructions: Using 250 KM area road sketch (attached), pinpoint location of "Point C" (identified in CRV-06 by RV-003). This information is necessary for cross-cueing other collection systems.

2. (S/NF/SK) Session: Monitor biased by prior sessions; strongly suspects tactical laser weapon involved. Source, after producing the word "energy" in S1, was moved directly into S4. This unusual protocol works for source RV-018 and he is comfortable/happy with it; seems to achieve desired site contact without traversing S3. Monitor used coordinate cue which was a composite of coordinates used in earlier sessions for Points 1 & 2 (refer to initial tasking data). S6 time line employed to identify a number of instances when the (object) was used. Source's "Point 2" description matched "Point C" (see above). Note: this source absolutely refuses to consciously confront site-connected death or to place himself in a S6 position where mortal/injurious effects might be detected. His generic, euphemistic term for this type of data is "ugly".

3. (S/NF/SK) Summary: Source perceived radiant heat from a very long tube with flat top and bottom, rounded sides and of very great length emanating from a flat/squat/rounded object. If one were to look down the tube from the "receiving" end the perception would be of bright, brown-colored, swirling, circling movement towards the percipient. From

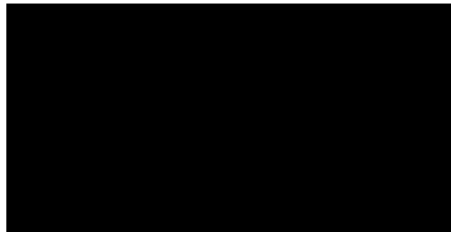
the side, the perception is of a tube; caramel-colored with a sheen inside. (Source would not place himself at the "destination" of this motion-in-the-tube because of (AI) "great fear and dread"). At "Point 2" source described place as rising, hilly, pale green (probably vegetation) with "surrounding activity/military trucks (not on a road) and loud motor sounds all around". Approximately 45 KM NNE (see source S6 sketch), source located a town the center of which seems to have a pattern of very straight-lined "streets" surrounded by irregular patterns (NFI). S7 produced the name "PFERK-LA-MA".
