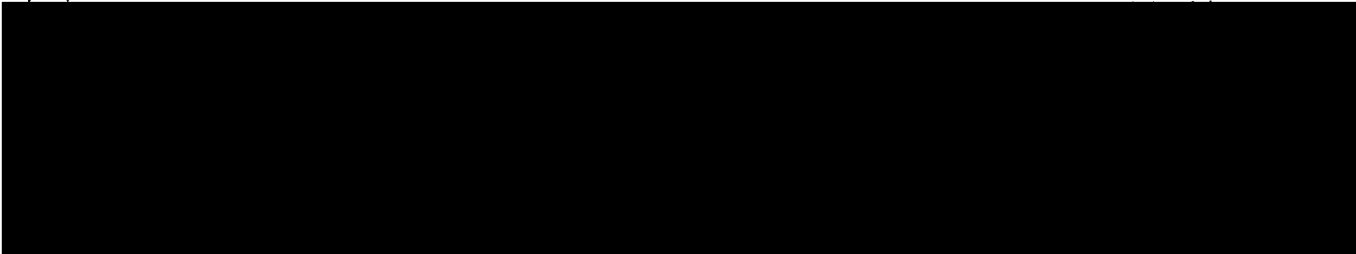

1. (S/NF/SK) TASKING: The Monitor was provided with a sheet of paper on which the following tasking had been handwritten:



provided none of the above cuing or data prior to the session except the encrypted coordinates, as per Coordinate Remote Viewing protocols.

2. (S/NF/SK) SESSION: During the session Source admitted to having "problems staying on signal", which was evidenced by Her somewhat disjointed and non-structured reporting techniques. The nature of Her problems, if any, were not revealed nor solicited prior to or during the session. During the actual session there were no reportable anomalies or incidents which may have affected or influenced the data provided by Source except that which is cited above.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) Source's initial "IAB's" were well structured impressions of, "flat land, brown, dry, crusty, rocky, warm, bright and open". Structures soon began to be perceived but with the "new" perceptions, the first evidence of Source's problems in the maintaining of the signal line began to appear in the form of, "miss-breaks", "confusion-breaks" and S4 concepts cited in the S2

phase. (SEE PAGE 2 and 3 OF SOURCE NOTES) Soon after, an AI Break of a, "feeling of swiftness" occurred with a concurrent AOL of "Rocket". (SEE PAGE 5 OF SOURCE NOTES). Following the AI Break, Source's structured responses seemed to improve and the data tended to become clearer and less ambiguous with the exception of an unusual single page of, "AOL Visuals of an open desert, mountain range, tanks, bunker, aircraft", all of which were essentially out of structure but very similar to other images provided by other Sources pertaining to this site. Source made several more IAB attempts to further objectify and gather information on the site which resulted in a list of various colors and an additional AI of, "closed in feeling". (SEE PAGE 7 OF SOURCE NOTES). At this point Source progressed to Stage Four perceptions.

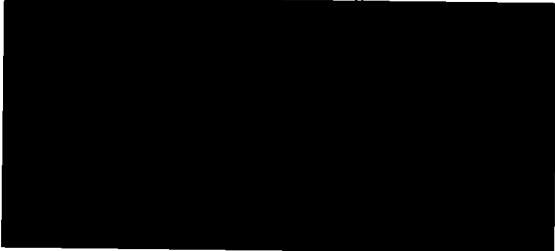
b. (S/NF/SK) Source's initial S4 perceptions were of an "overhead" view of an area described as a, "complex of some type, reflective...barren land, not a lot of vegetation, black spots...". In this area, Source perceived, "a low lying cluster of buildings...spread out, (with) markings, (later described as "probably numbers instead of letters"). Source was directed to prepare an interim summary at this point so that the material collected thus far could be consolidated and ordered in preparation for further tasking. The summary, located at PAGE 11 OF SOURCE NOTES, refers to the isolated barren area with a warm dry climate. Source further referenced the low, flat structures with "several black spots". One type of structure produced a, "rumbling noise" and another gave the impression of, "swift motion". An attempt to focus on the two types of buildings separately produced some limited additional data, i.e., in the "rumbling building" there was an oily smell and a feeling of, "slow movement, heavy", as well as a perception of, "denseness, compact, portable". (SEE PAGE 12 OF SOURCE NOTES). The examination of the other structure, (the "swift structure"), failed to produce any apparent significant data.

c. (S/NF/SK) At this point, the Source was given a "time-line" exercise in which the dates 15 April and 15 May 87 were the perceptual parameters. The cuing was, "an occurrence in that period". Source described a, "feeling of great heat, (a) sucking sensation, lots of dust, dryness, high pitched sound...(a) mistake, (a) miscalculation". (SEE PAGE 15 OF SOURCE NOTES). Source continued the process of describing a, "concrete structure, isolated, smell of gas, not many people, secure, a constant drone...loud rumbling", and AOL of, "(rumbling) from deep underground...". (SEE PAGE OF 18 SOURCE NOTE). The pace of perceptions then increase with, "frantic activity, trapped feeling, crushing feeling," and, "explosion caused by a rupture underground, natural causes, building sealed off, collapse, generates great heat, large clouds of dust and a fire maelstrom...". A second interim summary was prepared at this time which again references

the above cited occurrence in which there is a, "rumbling from deep underground...frantic activity, sealing off a building and a firestorm effect causing the flames to suck off the air and create high winds...". Attempts to further clarify these descriptions met with an unusual resistance when Source stated that She could not get rid of a feeling that the follow-up to this occurrence is a, "subtle change in political structure...a head of government's bad decision caused the occurrence and as a result (the leader) is being eased out of power". At this point the session was terminated due to time constraints and the above cited unusual reference which would have required additional detailed exploitation to clarify.

4. (S/NF/SK) OPS FEEDBACK: Following this session, it was learned that Source had recently been notified of Her acceptance to another position not associated with this office. This fact may have accounted for Her stated problems of, "maintaining the signal". Regardless of this other agenda, Source delivered a somewhat intriguing and worthwhile session. It's planned to conduct an additional session with this Source in the near future utilizing the Extended Remote Viewing (ERV) technology in an attempt to clarify the data She provided in this session.
