- 1. (S/NF) The target appears to be a structure allied with the concepts of storage and manufacturing. The target building is located in an isolated area. Soil excavation and movement also appears associated with the target. Two sources associated the target with the odors and tastes normally associated with that of toxic materials.
- 2. (U) The isolation of the site implies a sense of illegality and secrecy.
