

- (S/NF/SG/LIMDIS) Source A: SG1B
- he works for is that of a communicator or messenger who makes connections. His activities have included packaging illegal contraband for transport, for money and he is heavily relied on for his middle man role. He has had losses in his past and does not carry out operations from start to finish on his own. He is currently waiting for a deal to come through and something may come into fruition along these lines in August. He is afraid or should be afraid of who he talks to because if he is not careful word could get out. There is a woman around him he knows personally.
