1. (S/NF/SK) MISSION: Determine current location of the structure wherein Terry Waite is being held hostage.
2. (S/NF/SK) VIEWER TASKING: Describe the structure wherein Terry Waite is being held hostage. Describe a readily recognizable structure located in the immediate vicinity of the target structure.
3. (S/NF/SK) COMMENTS: No inclemencies noted. Viewer 018's sketch of the target structure correlates with the sketch provided by Viewer 011. Viewer initially placed the target structure in the northwest area of Beirut. This correlated with the general location described by Viewer 079. Viewer then changed his mind and indicated that the target structure was "off the map" to the southeast of Beirut. Viewer 018 chose a "replica" of the target structure with the presence of an odor of unleavened bread." Efforts to <sup>u</sup>focus Viewer 018 on the actual sketch prepared during the session were futile; therefore the session was terminated. It is possible that the target structure is off the map, <sup>but</sup> in the opinion of the monitor, this is doubtful.

*In monitor's opinion, Viewer 018 must left Beirut and brought himself right out of Beirut to find a replica of the target structure.*

2. (S-SS) TASKING: Describe the structure where Terry Waite is being held, and any specifically identifiable structures nearby. Locate his position in Beirut on a map.

3. (S-SS) SESSION CONDITIONS: PI: none AV: none.

4. (S-SS) RESULTS:

a. STRUCTURE: Impressions of a fairly tall flat-faced structure. It has a "humped" or slightly rounded top, which has a "lip" border along the front surface of the top (see sketch, page 2). There is another curved "lip" above what (AOL: appears to be a door). The color of the structure is white with brown smears. The walls have a (AOL: stucco-looking) texture which has the feel of a "glazed" surface.

b. NEARBY IDENTIFIABLE STRUCTURE: The only nearby identifiable structure I could come up with was long, narrow, seemed to be underground. It was moist and smelled bad, and (AOL: appeared to be a sewer or drainage pipe). This structure appeared to go under the target structure described in 4.a. above, at an angle to it (see sketch, page 9A).

c. LOCATION ON MAP: Dowsing method used gave the impression that the target structure was not in Beirut proper, but (if north is up on the paper) off to the southeast, outside the city. An impression was gained of a target structure inside the city (see X on sketch, page 11A), but this was accompanied by strong AI impressions that this was not THE target structure I was looking for.
