DURING TODAY'S SESSION, I FELT THAT I WAS IN AN OUTDOOR AREA WHICH WAS SECURE AND LOCKED IN. IT SEEMED THAT I WAS IN A LARGE MILITARY COMPOUND. THERE WERE LARGE AND SMALL STRUCTURES. THE COMPOUND WAS BIG, FLAT, AND HAD LITTLE ROLLING HILLS. IT WAS RATHER WARM AND BREEZY.

I THEN WENT TO THE OBJECT OR STRUCTURE WHICH I WAS ASKED TO ACQUIRE. IT SEEMED THAT THERE WAS A LARGE CIRCLE AND I DO NOT KNOW IF THE CIRCLE WAS AT THE TOP OR BOTTOM OF THE OBJECT. BUT I DON'T THINK IT WAS CONNECTED TO THE OBJECT. THE OBJECT WAS BIG, THICK, WHITE, LONG, AND SLENDER. IT WAS MAN-MADE AND IT WAS HARD.

I COULD SEE THAT SOMETIMES PEOPLE COME HERE AND SOMETIMES
PEOPLE ARE NOT HERE AT ALL. HOWEVER, WHEN THERE ARE PEOPLE HERE,
