1. (S/NF/SK) MISSION: Locate [redacted] and determine if [redacted] has been in contact with the kidnapers, either directly or indirectly. Determine if [redacted] has been in contact with the hostages; and, if he has been in contact with foreigners. Determine if Iranian authorities have issued instructions to initiate terrorist activities against US interests as a result of firing upon the Iranian Jet Airbus by the Vincennes.

2. (S/NF/SK) VIEWER TASKING: Tasking levied on viewer in accordance with mission requirements reflected in Para 1.

3. (S/NF/SK) COMMENTS: No Inclemencies noted. There exists no data bank from which to evaluate the results of the topical search surrounding the projected terrorist activities. A Summary of Information is at ENCLOSURE 1. Every effort should be made to insure specificity in the exploitation of further and future requirements.

4. (S/NF/SK): EVALUATION: *High degree of correlation between info furnished and known ground truth, according to [redacted] Terrorist Desk Officer DIA. Search also revealed plausible data as to current location.*

SUMMARY OF INFORMATION

- SG1A [REDACTED] was perceived as a middle-aged (forties), dark-skinned individual of slender built and medium height, about 5'7". His ethnic origins could not be readily perceived; he appeared to be a Lebanese moderate, but the product of a mixture of races with roots based (partially) in Zaire. He is currently located at the "Daytime Hotel" (Days Inn?) located in Beirut in the immediate vicinity of a site identified as Mesrobian School. See copy of a partial map of Beirut at ENCLOSURE 2. On several occasions, [REDACTED] can be found in the northwest Israeli town of "Liman" located immediately south of "Beze" an Israeli city/town located near the Israeli/Lebanese border. See ENCLOSURE 3.
- SG1A [REDACTED] has served as an Israeli source of intelligence information. Although he is a "country man" by origin, he possesses excellent battlefield expertise and he has a keen, perceptive mind. He has had no direct, contact with the kidnapers or the hostages. His [REDACTED] current knowledge of the hostage situation is derived from indirect sources in Lebanon. It appeared as if [REDACTED] was more knowledgeable than he professes to be. It was perceived that he could be used to advantage at a later date as negotiations for the release of the hostage have developed further. Noted that [REDACTED] current superior, described as a somewhat older gentleman, will be amenable to exploitation at a future date. [REDACTED] current or former military affiliation could not be determined.

RESULTS OF TOPICAL SEARCH

No instructions have been issued by Iranian authority to launch retaliatory terrorist activity against US interests in view of recent events and threat innuendos. On the contrary, Iranian representatives will be embarrassed as the result of terrorist activities initiated independently by unwieldy and uncontrollable (Iran-affiliated?) terrorist groups in Europe. There is a high probability that an act of terrorism will be attempted on 31 July 1988, in Europe (West Germany), against an Eastern Airline Flight. This act of terrorism will be initiated in retaliation for the conviction of Hameidi who is currently on trial in West Germany. There is a likelihood of a second act of terrorism that aimed at prominent members attending an ~~an~~ international meeting in Munich West Germany in September 1988.
