1st floor in area 2 is full, walls or floor grey, door connects structure w/ small regular windows, maybe barred, fairly surrounded by chain link fence w/ barbed-wire top + lights. old

2nd floor has long hall, green floor, person at desk controlling access to one area. Offices. Room containing many files. Records deal w/ people present at site. 2 overall groups - subjects, + others produce + keep records. Records keep track of progress of subjects individually. Show progress + regress during procedures, until final termination when subjects are either "dead" or "farmed out" to a holding area where they stay indefinitely (like being in retirement, a nursing home, + a mental hosp. all in one.) Subject never leave system altogether.

Procedures involve energy introduction to subject, which either incidentally or intentionally causes pain. Observers/record makers expect this, are not mimicked or cruel, but are also not beneficial or empathetic. They are detached, interested,
