1. (S/NF/SK) INTERVIEWER TASKING: Project N-1 is the first of five similar projects (N-1 through N-5), in which the Viewer will be tasked to describe in detail a document that is being maintained in the DIAC. In addition to data pertaining to the document, the Source will also be tasked to describe the general configuration of the building in which the document is located (the DIAC), the actual room and the container. The Source should not be initially told that the target is a document but can be told after the sessions begin at a time chosen by the Interviewer and only when necessary to avoid a "drive". It should be noted that the Interviewer is still unaware of the true nature of the document represented by the label, "N-1".

2. (S/NF/SK) SOURCE TASKING: Source was told that this was the second effort to be conducted on the same target that He worked previously. Source was told that He should begin His efforts by returning to the building described in the previous session but should remain outside the building until told to focus on other aspects of the target. In addition to this data Source was initially provided the same encrypted coordinates as the previous session as per Coordinate Remote Viewing (CRV) protocols. During the actual session, Sources descriptions began to take on striking similarities to the DIAC and at that point the Source was given the actual tasking, e.g., focus on a specific document within the structure and describe it in detail. He was told that in the opinion of the Monitor that He was probably in the correct location but He was not provided any other confirmatory information concerning the nature of the building or the fact that it was the DIAC or "building 213" as He commented on during the session.

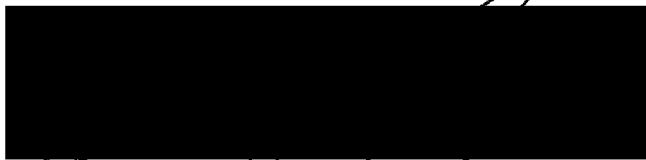
anomalies which may have influenced the data obtained in this session.

4. (S/NF/SK) SUMMARY: Source furnished the attached summary which was prepared following the session and submitted to the Monitor within 24 hours after the session. The completeness of the typewritten summary has been compared to the Monitor's notes and all omissions, changes, and/or corrections have been verified as acceptable by the Monitor. The information provided in this session was somewhat more conclusive than the previous session and is keeping with this particular Source's habit of spending one or two full sessions "getting close to the target" before providing substantive data of a reportable nature. Source has a strong impression that the building he is in is the DIAC or building 213, (a building across the river from the DIAC in which Source has previously worked). Source struggled hard to provide the physical descriptions of the document in question, which was essentially a new category of tasking, and as a result, he may have attempted to either "ERV" the session or to "force analyze" the data. In any case, his descriptions were scant but may prove to be the most exact descriptions once "feedback" is provided. Future sessions will be conducted with an eye to attempting to get this Source to narrow his focus of perception in a manner that will hopefully eliminate his current tendency to "explain" the document as opposed to simply describing it.

SESSION SUMMARY

SESSION: 27 AUGUST 1987, 1304 - 1412 HRS

ASSOCIATED WITH THIS TARGET IS A LARGE, MULTI-STORY STRUCTURE (see sketch, page 4). THE LOWER PORTION OF THIS STRUCTURE IS GRAY, HARD, SMOOTH, AND COOL TO THE TOUCH. THERE IS A PART OF THE STRUCTURE THAT SEEMS TO BE A LIGHTER SHADE OF GREY AND THE UPPER PART A DARK, BLUE-BLACK.

WITHIN THE STRUCTURE, ON AN UPPER FLOOR, THERE IS AN AREA WHICH HAS AN OFFICE, CUBICLES, DESKS, AND WORK AREAS (AOL-like bldg 213 or DIAC). THIS IS AN OPEN AREA, BUT SECURE (AOL-vault-like). WITHIN THIS AREA IS A DOCUMENT. THE CONTENTS OF THIS DOCUMENT APPEAR TO BE VERY CONTROVERSIAL BETWEEN SCIENTIFIC AND POLITICAL COMMUNITIES. IT SEEMS TO HAVE SOMETHING TO DO WITH A MORAL ISSUE. THE COVER OF THIS DOCUMENT IS REDDISH, OR REDDISH-BROWN IN COLOR WITH A BLACK BORDER ON ONE SIDE. CONTAINED WITHIN THIS DOCUMENT IS WRITING AND SYMBOLS. SOMETHING TO DO WITH MATHEMATICS, FORMULAS, ETC. THERE IS SOMETHING ELSE THAT IS CONNECTED WITH THIS DOCUMENT (see page 7). IT HAS THE APPEARANCE OF A COMPUTER PRINT-OUT AND CONTAINS LISTS OF SOMETHING (AOL-like a targeting list, a list of strategic targets).

WHEN ASKED TO DESCRIBE THE ORIGINATORS OF THIS DOCUMENT THERE WAS SOME CONFUSION. THERE IS A FEELING THAT WHOEVER PRODUCED THIS DOCUMENT, WERE NOT NECESSARILY AMONG THE ORIGINATORS.
