- 1. (S/NF/SK) INTERVIEWER TASKING: Project N-1 is the first of five similar projects (N-1 through N-5), in which the Viewer will be tasked to describe in detail a document that is being maintained in the DIAC. In Source's initial session the data pertaining to the actual structure was considered to be highly relevant. The data pertaining to the actual document was less precise and contained more ambiguities. In this session, therefore, the Source was tasked to move directly the structure and after a few moments of "anchoring" at the site, She was tasked to move directly to the document. No other cuing or descriptive data pertaining to the document was possible since the Interviewer is not aware of the nature of the actual document. Source was provided the same encrypted coordinates as the initial session, (250501/095323), as per Extended Remote Viewing (ERV) protocols.
- 2. (S/NF/SK) SOURCE TASKING: Source was told to recall a session conducted about "two weeks ago in which you were tasked to described a building and inside that building there was one particular document. In todays session, I want you to re-acquire that building and eventually when I tell you to do so, the same document. We will then do some more work on the document". Source accepted this new tasking without any questions or comments.
- 3. (S/NF/SK) INCLEMENCIES: There were no reportable incidents or anomalies which may have influenced the data obtained in this session.
- 4. (S/NF/SK) <u>SUMMARY</u>: Source furnished the attached summary which was prepared following the session and submitted to the Interviewer within 24 hours after the session. The completeness of the

typewritten summary has been compared to the Interviewer's notes and all omissions, changes, and/or corrections have been verified as acceptable by the Interviewer. The information provided in the summary was found to be complete and required only minor modifications, clarifications or additions by the Interviewer. This additional data is as follows:

- a. (S/NF/SK) Source's description of the actual building, the DIAC, continued to be surprisingly accurate from the aspect of the nature of perceptions as "seen" by the Remote Viewer (RV) and tended to confirm that Source had indeed re-acquired the proper site.
- b. (S/NF/SK) Throughout the session Source's data seemed to indicate Her perception that the document was a scientific or technical manual of some sort. As the session progressed Source began experiencing recognizable fatigue and as a probably result of this fatigue Her data took on a different concept. In the period following a full hour of session the material seem to deal with some sort of light emanating equipment of an indeterminant nature. Soon after, as a result of these disparities, the Interviewer terminated the session.
- E a (S/NF/SK) COMMENTS: As a matter of record, it should be noted that in an ERV session the tendency towards fatigue occurs after a about fifty minutes of session, regardless of the experience, physical well being or sex of the Viewer. When fatigue does occur the mental responses of the left brain, tasked with maintaining the bodies normal functions during a session, may have to begin working harder to overcome this fatique as a result the left brain activity may be overcoming the control ceded to the right brain during the actual session. There does not appear to be any "return for the money" by trying to force a Viewer to continue to report after this period of time since experience has shown that after the one hour mark the data will begin to get confusing, contradictory or symptomatic of an AOL drive. It is believed that this may have accounted for the "sudden" change in Source's data towards the end of the session.
