

TO THE NORTH OF THE STRUCTURE, I COULD SEE THE MOUNTAINS.

THIS IS A RESIDENTIAL AREA.

AS I WAS WATCHING THE WATER, I COULD SEE THAT IT ENDED INTO A WIDE BODY OF WATER. THERE WAS A WALL OR A BRIDGE THAT STOPPED THE WATER FROM ENTERING THE CITY. ONCE THE WATER REACHED THIS POINT, IT WAS NOT RUSHING OR MOVING. IT WAS A CALM BODY OF WATER. I COULD SEE A LARGE CITY OR TOWN ON A HILL.

OVERALL, THIS AREA IS BEAUTIFUL.
