1. (S/NF/SK) MISSION: Determine remote viewer's ability via WRV methodology to collect foreign intelligence against a target document shielded from normal perception. Determine ability to locate the document.

2. (S/NF/SK) VIEWER TASKING: Based on information provided in Session Number 08, confirm/disprove the location of the structure housing the document. The results of this session were recorded via radio tape.

3. (S/NF/SK) COMMENTS: No inclemencies noted. Viewer 079 was advised not to feel obligated to defend or justify WRV methodology. On 29 Jan 88, Dr Vorona authorized and encouraged the use and development of WRV. Information related to this methodology as understood and practiced will be made available to all personnel ^{as a potential means of} ~~with a view towards~~ enhancing the knowledge and capabilities, ~~of personnel within the program.~~ ^{breeding} A summary of findings related to the search problem is attached to this report.

Cameron Station, as previously reported by name and under the ID of (H-1) is indeed the (general) target site area. More precisely, the target (structure) is located off Duke Street between Landmark and Cameron Station, between the "Transportation Depot and Cameron Station." In an effort to be more precise, the added direction of somewhat "left of Landmark ^{was given.}" The transportation depot is connected by rail (rail spur?) and ^{Further} connected by road to Cameron Station. There is evidence of military buses in the area; civilians (retired military mainly) and active duty personnel are in evidence. Other identifiable data includes the presence of an exhibit, a "Stagecoach Exhibit."[Interviewer called a halt to the search at this point and indicated that if further refinement were needed additional maps would have to be procured to provide additional points of reference ^{to afford} and greater clarity in the nature and type of available structures]......

George was the principal source of information during this session. A new name surfaced, that of "Jonathan." Jonathan was already known to 079.

UNIVERSAL TRUTH (Natural Law) - MAN TRUTH (Psychological Truth) - EARTH TRUTH (Laws of Physics) will be addressed as work

progresses and methodology is refined, understood, and applied. George indicated they (team of friends) were ready to welcome Dr Vorona and to do their best against the target. George added that Dr Vorona has witnessed channeling before; this will *serve to* facilitate matters.
