1. (S/NF/SK) TASKING: The Interviewer was aware of the fact that the actual target was a personality of some importance ██████████
 ██████████ The actual identity of the person was not made known. Source was told prior to the initial session that this target was a personality since He had just recently unsuccessfully attempted a similar project with another personality. The identity or country of origin of this person was not made known to the Source. Prior to the second session Source was told that the personality described in the 1st session was, "most probably not the correct person nor the correct geographic area of the world". Prior to each of the three sessions, Source was provided encrypted geographic coordinates, as per Extended Remote Viewing (ERV) protocols, to preclude inadvertent geographic cuing. No other cuing or descriptive data was provided to Source except that listed above. Source targeted against the material located in an envelope marked #2, which remained in the possession of the Interviewer throughout the session.

2. (S/NF/SK) SESSIONS: Source's initial session seemed to swell on an individual of latin American origin and living in a Latin American region. This, obviously was not the personality targeted in the envelope but it was impossible to state whether there may have been some indirect relationship to this individual and the target personality. It should be noted that Source was born and raised in Texas and raised in a conservative family background which may cause Him to label foreign appearing individuals with Hispanic characteristics. During the actual sessions there were not reportable anomalies or incidents which may have affected or influenced the data provided by Source. Only ERV protocols were utilized in the conduct of these sessions.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) Information provided by Source during the initial session could not be readily correlated to the target personality. The data was ambiguous and referenced characteristics which could, with reasonable certainty, be excluded as non-relevant to the actual target personality.

b. (S/NF/SK) In session two, Source began by describing an area where expensive cars were located, which soon changed to an office environment where there were, "clean, light colors...matching equipment...". After some "winking around", (flashes of various images), Source was then targeted to, "someone of importance", and began reporting on a man, "wearing a white overcoat with khaki colored clothes underneath...". This individual is further perceived as sitting at a table with, "a pair of scissors...his work has something to do with a little table which looks out of place in the room, like a military folding table...". The description of the individual included references to, "a little gray hair...some settling at the waist...maybe balding...". The individual is perceived as working around various types of chrome colored equipment and having an education that was derived from some sort of, "firm, stable school...all other efforts to specifically identify other characteristics of this individual, i.e. family, employment, interests, health, etc., met with similar nebulous and ambiguous results.

c. (S/NF/SK) A final session, (session #3 of this report), was conducted in an attempt to resolve the rather sketchy and ambiguous data provided thus far. In that session, Source began by describing a building complex with an older multi-story building, weather beaten and possibly unpainted. When specifically targeted against, "the person we are interested in...", Source reported on an individual wearing a, "brown jacket, feels like leather...sitting at an old wooden desk, looks like a medicine bottle on it, beat up, cigarette burns...". This individual was further described as, "plain, slightly overweight, small mustache, round face...mild mannered...receding hairline, wears glasses...(self assured). There was an impression that this individual drives a, "blue truck, like an electricians repair truck...". An attempt was made to ascertain any data on this individual's position, but Source was only able to perceive the concepts of, "manilla folder, files, storage, manager...cameras and machines and things mechanical...". From this point on further efforts to gain non-ambiguous and more specific data on this individual met with confusing images, unclear references and data which could not be attributed to any specific individual.

4. (S/NF/SK) OPS FEEDBACK: Many of the varying and widely

dispersed images were not referenced above for technical reasons, i.e., Interviewer's belief that the data was too analytical, not derived as a result of remote viewing and/or the data was unrelated to the task at hand. Source, an extremely intelligent person has a very logical and analytic mind which may be a bar to His use in telepathic operations in the ERV technology. Further review should be conducted to determine if, a) this is the fact, and b) if this area of operational weakness can be enhanced through training.
