1. (S/NF/SK) TASKING: Prior to the first session covered in this report, Source was told that in the opinion of the Operations Officer, (and the Interviewer), the previous session was inconclusive in providing data pertinent to the actual target. Therefore, during this session, Source was to, "place the results of the previous session behind you, "and not to confuse these results with the data obtained in this session. In the second session covered in this report, Source was unable or unwilling to affect telepathic contact with the target and the session was thus terminated. Prior to this second session, the Interviewer had been made privy to the actual identity of the individual being targeted,

In each session Source was provided the same encrypted coordinates as the initial session (467600/506198), with no other cuing except as noted above. In all three sessions to date, Source has been targeted against the individual stated above, who was located in a sealed envelope marked "#1".

2. (S/NF/SK) SESSION: During the first session covered in this report (session #02), Source was able to "access" telepathically the target individual. This contact became very probing and in fact an apparent health problem or personal crisis on the part of the target was perceived empathetically by the Source. The depth of the contact between Source and the target was such that Source became emotionally affected by this "crisis" and wept openly causing the session be terminated. This incident further prevented Source from participating in any type of post-session interviews to resolve this anomaly. Later Source was told that it was desired that she plan for a future session against this individual to

resolve this situation. At that time Source willingly consented to this course of action. In that subsequent session, however, Source was either unable or unwilling to affect the necessary telepathic contact with this target and the session had to be prematurely terminated with no further information being derived pertaining to the target individual. Each session was conducted entirely utilizing ERV protocols.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) Source began the first session covered in this report by describing a, "grey stone building....squarish, broadfaced....flat roof....(several) stories tall, (and furnished with) heavy, dark wood". The building contained a reception area and many separate offices. The overall impression of the work space was dreary functionalism in a building still bearing much of its older ornateness from another time. Other areas of the buildings gave the impression of T.V. monitors, conference rooms, partitions and small rooms arranged, "like a place where two people sit and talk to one another....(possibly) an interrogation room". In one office, possibly protected by armed and uniformed guards, there was an impression of an opulent office in which there was, "a tall, distinguished man".

Source was directed to access this man b. (S/NF/SK) telepathically and to report on specific data pertaining to him. Source described this individual as, "well educated (with possible) aristocratic (background)....very strict". There may have been some youthful homosexual experiences. This individual is, according to Source, married with two teenage children, a boy and a girl. His wife is politically, "connected" which may have had an influence on this individuals rise to his current position of prominence. The target individual is very concerned about a hereditary degenerative muscle disease. It was unclear whether this individual was concerned for his own health or the health of a family member. Additionally, this individual allegedly has heavy financial burdens. The target is approximately fifty years of age and is torn between feelings of nationalism and patriotism and, "philosophical ideas in opposition to (these altruistic emotions)". He is a decision maker at a governmental level that directly involves him with matters of international importance.

c. (S/NF/SK) At this point in the session the Source received a strong image of pain associated with the target. This paid was perhaps a form of mental anguish rather than actual physical pain. Associated with this feeling of pain was a powerful image of a "painful" decision that had to be made. This decision appeared to the target to be "impossible" and he was experiencing great difficulty and anguish in trying to resolve this matter.

ci " (S/NF/SK) The powerful nature of the emotion cited above caused an empathetic response in Source who was forced to terminate the session due to Her own personal sense of anxiety and overwhelming sorrow. Following the session, as is normal protocol for Extended Remote Viewing (ERV), Source was tasked to prepare a written summary of Her impressions of the this individual. The depth of the empathetic response that Source experienced with this target was so powerful that She could not, "deal with even writing about this guy right now". In the subsequent session also covered in this report, Source was tasked to access the work area of this person and eventually the individual himself. She was unable to access the person and perceived only confusion and an inability to stay with the target. It was decided that the trauma of the last session was still having a residual effect on the Source and was severely limiting Her ability to adequately access the target personality. For this reason, the session was quickly terminated with no further reportable data pertaining to this individual.

e. (S/NF/SK) All notes pertaining to Source's participation in this operation are located in the mission field dossier located at this office.

4. (S/NF/SK) OPS FEEDBACK: Following the final session, Source, although not nearly as visibly shaken as in the above cited "unusual" session, was nevertheless, reluctant to deal with this topic. She even went so far as to state that She, "was not very good when it came to dealing with people during sessions and did not believe that she could effectively provide substantive data when the session required her to (access" people telepathically". This response may have been an anxiety response to this one individual or a very real apprehension on Source's part to be utilized in telepathic accessing for reasons She may not even understand Herself. In any case, it is recommended that this Source be relieved of further tasking on this operation.
