1. (S/NF/SK) TASKING: Prior to this session, the Interviewer was provided with a sheet of notebook paper on which the following handwritten tasking had been prepared: "Describe person (see envelope for cuing). Suggestions: Physical description, profession, habits, education, location (now?), health, telepathic message, etc. Note: In the envelope(s) (don't open it) are specific identifying documents". Included with this tasking were three sealed envelopes each bearing a different encrypted coordinate and numbered 1 through 3. The actual choice of the envelope was to be left to the Interviewer/Monitor. No other cuing was provided to the Interviewer/Monitor at this time. The Source was not told that the actual target was an individual and only provided the encrypted coordinates as per Extended Remote Viewing (ERV) protocols. On this session the Source was targeted against the identity of the person concealed in the envelope marked #1.

2. (S/NF/SK) SESSION: There were no unusual or reportable incidents which occurred in this session or which may have influenced the data provided during this session. The session was conducted entirely utilizing ERV protocols.

3. (S/NF/SK) SUMMARY: Source was unable to provide data which could be considered pertinent to the actual tasking, i.e., a particular personality. Data pertaining to the individual reported upon in the session, a rather martinet, opportunistic senior officer, was far too general to be attributable to more than chance or analytic overlay. Source will be re-targeted on this tasking at a future date.

4. (S/NF/SK) OPS FEEDBACK: In the next session, Source will

again be retargetted against the personality identified in envelope #1. Following that session, the Interviewer has been directed to unseal the envelope but not to reveal the contents to the Source in an attempt to determine, A) if the material that Source has provided to date can be attributed to this individual and B) the nature of the type of targeting being requested for this mission. This may aid the Interviewer in conducting future sessions on the other personalities which shall remain sealed until further notice.
