- 2. (S-SS) The target location was a safe , and the actual target was a document (information provided by monitor). I had become interested in something else in the safe at the end of, and after the last session, and let this A.V. drive all my perceptions for the entire first part of the session.
- 3. (S-SS) Once it was pointed out that the document was the thing of interest, the following perceptions were gained:
- a. The document seems to contain drawings and charts and tables. I could find no photographs in the document, itself, although there was the impression that some separate photographs may be kept with the document.
- b. There was the feeling that the document does not request information, but gives it. It seems purely informational in nature.
- c. The contents of the documents seems to be about machines, requirements, and properties. It seems to deal heavily with precision requirements.
- d. When asked for a language, I got the impression that it might be Czech, or some related slavic language. I did not get the impression that it was in Russian.
- $eals_{ extsf{vagae}}$  e. When asked about end products, there were repeated vagae visuals  $extsf{e}f$  airplanes, but they did not feel "certain".
- f. When cued to give the location of the document, I got the image of somewhere in the SW US. Cued with its location 1 week ago, I got the New England area. Cued with its location 2 weeks ago, I got an impression of central Canada, just north of the US border.
