1. (S/NF/SK) TASKING: On 2 April 1987, Source was provided a small opaque envelope which had been prepared for Him by hand lettering the words, "Project "M", (the mission reference name), across the front of the envelope. Additionally the envelope had the words, "Tasking #1" written below the project number, indicating that this was the initial tasking on this project provided to Source. A small notation, "Date Due: 3 April 1987" was lettered in the lower right hand corner of the face of the envelope. Sealed inside the envelope was a small sheet of notebook paper on which was written the following tasking: "Tasking #1 -Describe the vehicle(s) as 182478/836131". On 3 April 1987, as indicated, Source provided the written results of His impressions on this tasking. After a review of these results, it was decided to provide Source with another sealed tasking envelope which modified the original tasking to read: "Tasking #2 - Describe the vehicle(s) of special intelligence interest at 182478/836131." Source responded on 3 April 1987, with a written summary of His impressions, (see paragraph 3 below). On 3 April 1987, Source was advised to retain the same sealed tasking since, "your written responses were in some way correct but in other ways somewhat ambiquous." The results of this second tasking of the same sealed envelope were due by close of business, 6 April 1987. Source's written results of this repeated tasking were submitted on 6 April 1987 and are also included at paragraph 3 below. In each of the two tasking sessions included in the report, Source was told to keep the envelope in His possession and to provide a written summary of His Remote Viewing (RV) perceptions pertaining to the tasking sealed within the envelope on the suspense date indicated on that envelope. No other cuing or restriction/guidance were provided to Source except to remind Him not to unseal the envelope and to provide His written results by close of business on the

(S/NF/SK) SESSION: Source reported that during His relaxation phase in preparation for a RV of tasking #1, He heard or sensed a voice calling to Him but He chose to ignore it to complete His mission. On 6 April 1987, while completing an RV session on Tasking #2 in a darkened operational room, Source was suddenly brought back from His altered state of consciousness when, "something or someone" attempted to snatch the tasking envelope from His hand which was crossed over His chest as He lied on the The incident caused Source to experience a sudden surge of anxiety and He turned on the lights and left the room. completed a written summary of His impressions up to that point in the session but was certain that some unknown type entity was attempting to initiate some sort of contact with the Source. A special session to facilitate this contact was conducted prior to permitting Source to attempt to continue operational tasking on this target. All three sessions, the two operational sessions and the one "special session" were conducted without Interviewer assistance, interviewing, or prompting by any other individuals. Other than the incident reported above, Source did not report any other unusual anomalies or incidents which may have influenced the data provided in His summaries.

### 3. (S/NF/SK) SUMMARIES:

a. (S/NF/SK) The following narratives, contained within quotation marks, are an abridged copy of Source's written impressions pertaining to the tasking provided to Source as explained above. These summaries have been editorialized, (as indicated), the undersigned for clarity, grammar and structure. The actual unabridged summaries are maintained in the mission field dossier at this location along with all other material relevant to these taskings, i.e., the envelopes, tasking sheets, sketches, etc.

3 APRIL 1987 - BEGIN SUMMARY: "(There is a) large structure (which) I originally think is (a) large farm house...(the) structure is inside a circular area of some sort, (an accompanying sketch depicts a box like roofed structure centered within a wide circular arrangement similar to a path, moat, thick wall etc.). There are probably some other smaller structures within (the) circular area. As I attempt to move in closer (to) the large structure, I find myself moving through the (surface of the ground). Perhaps (at a depth of) 20-30 meters under the ground is an open area, tunnel-like. (The) walls are dirt and "raw", not finished. (The) area is lighted. (I) follow back for a ways (to a place where there is a) dirt ramp leading up. I come up (and) look around for something to focus on. (I) see a soldier, a man in uniform, in a jeep-like vehicle. (The) vehicle pulls into a camp

which has a semi-transparent feeling. (There are) tents with reinforced floors and sides. (The camp is) located below (a) ridge. (The) terrain is rough and rocky. There is a large metallic structure here that I call an antenna or tower but (I) have no reason for doing so. (The) camp has a military feel, but there is not much activity. There are not many people here now. I am confused. I am not sure which of the sites are the target or if they are connected in some way. Relaxation and site contact were good but I seemed to lack some control. (I) moved around and never really focused on anything for long."

6 APRIL 1987 - BEBIN SUMMARY: "(A) flat, lightly rolling landscape. (It) looks somewhat barren. (The building) is not near as large as I thought last time. There is another structure a ways away. In the background is a steep rock formation, (an accompanying sketch depicts a rather craggy and abrupt mountain region reminicent of the European Alps). There is an opening in (the) rock, (an accompanying sketch depicts one of these rather sheer mountains with a square opening like a door at the base). this point. It took a side trip (but) I do not know where I went. (I) got back in control and entered the opening. (There were) no people or security (systems) at this point. (I) moved across (a) flat floor. (The) area is dark but not pitch black. (I) moved across (the) floor to (a set of) wooden steps. (The) steps lead down one level, ( four or five meters), to a lighted area. is a) table at the side of (this) area. (A) gray work table. move down to take a look at (the) activity...(NOTE: From this point on the Source begins to describe the circumstances of the attempt by an entity to contact him) ... (The) envelope (containing the tasking) jumps in my hand. (I) feel a tuq. I instantly return to (the operational) room and turn the lights on. (I) make a quick check and then...return to the other building...Last Friday I thought I heard a voice but ignored it to get to the target" END SUMMARY.

- b. (S/NF/SK) A review of both written summaries revealed several references to known or suspected aspects of the target. According to a subsequent review by the Operation's Office, the actual target however, does not seem to have been addressed in a manner sufficient to state that good site/target correlation has been achieved. The Task Monitor was instructed to continue to provide Source additional tasking, as supplied by the Operations Officer in an attempt to force the Source to answer the specific intelligence question.
- 4. (S/NF/SK) OPS FEEDBACK: As stated above, Source apparently has only managed to provide several items which could be considered site relevant. It is the opinion of the Operation's Officer and the undersigned however, that Source's general direction of

descriptions tends to indicate that He is on the trail of the target and will, perhaps, have a breakthrough. This will, however, only occur after the matter of the external entity is fully resolved in Source's mind. To accomplish this, Source will be granted a full session to attempt to re-contact this interfering force and to attempt to resolve this matter.
