MEMO FOR: OPS

SUBJECT: SOURCE 101/UTILITY ASSESSMENT "M"

1. Source was tasked to describe the "target vehicles" rather than describe/access/report against the target of intelligence interest via geographical coordinates or some other traditional levy.
2. There is no evidence of guidance or instructions given source on how to cope with a major inclemency (encounter) in the first session. Sessions 03 and 04 appeared inopportune conducted in the absence of such guidance.
3. It seems unrealistic to expect source to function operationally under conditions dominated by an acute sense of fright (whether admitted to or not). Source is aware of the "Patrick" tape and the procedures used to cope with a similar encounter any be of use to him.
4. Source went home to work subsequent to the incident. At a minimum, Source no longer feels comfortable in the "ops building". Under suitable pretext, an interviewer should assist in helping him cope with the noted inclemency.

Source 101 was apparently unable to access the target because of a major inclemency encountered early in the session.
