THE FOLLOWING IS PROVIDED PER REQUEST:

A. BACKG OUMD: THE USAMIA HAS CONTRACTUAL INVOLVEMENT WITH SRI RELATED TO SOVIET STRATEGIC DEFENSIVE MISSILES SYSTEMS TECHNOLOGIES. THIS INVOLVEMENT HAS BEEN ON-GOING FOR A NUMBER OF YEARS. IN MID 1976. DURING THE COURSE OF THESE EFFORTS, USAMIA BECAME AWARE OF DR. H. PUTHOFF AND MR. R. TARG'S WORK AT SRI RELATED TO PARAPSYCHOLOGY RESEARCH. SINCE THE LOCAL R&D COMMUNITY HAD EXPRESSED INTEREST IN SOME APPLICATIONS IN THIS AREA USAMIA INVITED PUTHOFF AND TARG TO USAMIA FOR DISCUSSIONS WITH ALL INTERESTED PARTIES. THIS DISCUSSION WAS HELD IN LATE 1976 AND AGAIN IN EARLY 1977. AS A RESULT OF THESE MEETINGS THE USAMIA IMPLEMENTED A TASK UNDER CONTRACT DAAK40-77-C-0170 IN AUGUST 1977 WITH SRI, USING R&D FUNDS. THE FUNDING LEVEL FOR THIS TASK WAS APPROXIMATELY \$80,000. THE STATEMENT OF THE TASK IN THE SCOPE OF WORK RELATED TO THIS EFFORT WAS SIMPLY STATED "INVESTIGATION OF UNCONVENTIONAL DISCRIMINATION TECHNIQUES". IN AUGUST 1977 SHORTLY AFTER THE CONTRACT WAS SIGNED USAMIA REQUESTED THAT SRI FOLLOW UP ON PREVIOUS DISCUSSIONS WITH A LETTER OF SRI INDORSEMENT FOR THE RESEARCH OF PUTHOFF AND TARG. (INCLOSURE 1). IN SEP 1977 A MORE DEFENITIVE TASKING STATEMENT WAS SUBMITTED TO SRI OUTLINING USAMIA'S OBJECTIVES. (INCLOSURE 2). THE PROGRESS OF THE WORK THUS FAR IS GIVEN IN INCLOSURE 3. ON JUNE 19, 1978, THE SRI CONTRACT MONITOR MET WITH MR. RAY LEADABRAND OF DIA TO DISCUSS A CONCERN THAT HAD

 ANOTHER UAH COURSE IS SPONSORED BY THE FREE UNIVERSITY STUDENT GOVERNMENT

 ASSOCIATION. THIS COURSE DEALS WITH VARIOUS SPECULATIVE ASPECTS, BUT

 INCLUDES UFO'S, ETC. THERE ARE ALSO COURSES OFFERED BY THE PSYCHOLOGY

 DEPARTMENT ATTAINS STATE UNIVERSITY IN ATHENS, ALABAMA, THAT ARE

 OFFERED AS PSYCHOLOGY ELECTIVES. THESE COURSES ARE ALSO GENERAL IN

 NATURE. TO OUR KNOWLEDGE NONE OF THE ABOVE PROGRAMS COULD BE CLASSIFIED

 AND RESULTS. INCLUDED AS INCLOSURE 5 IS THE RESULTS THUS FAR AS TO

 FUTURE PROGRAM DIRECTION AND RESEARCH APPROACHES. THE RESEARCH APPROACHES

 WERE FORMULATED AND SUMMARIZED FROM A SRI REPORT ENTITLED "PSYCHOENERGETIC RESEARCH: SUGGESTED APPROACHES" AND IN THE OPINION OF THE USAMIA

 WOULD REPRESENT A SOUND ARMY R&D PROGRAM IN THIS AREA.
