- 4. Sole Source Justification:
- a. SSPD has examined the available contractor-expertise for evaluating the potential abilities of individuals in locating, collecting, assessing and protecting data meeting the peculiar mission and operational requirements of this organization.
- b. McDonnel Douglas Astronautics Company (MDAC)-Huntington Beach has a long history of involvement with the intelligence community involving data collection, processing and assessment, and was selected as sole-source contractor for several reasons. First, MDAC has been one of the few firms seriously involved in developing the unique technology with which this project deals, and has managed to put together and synthesize into a cohesive package the variety of disciplines and tools needed for this particular evaluation project. In addition, several of the evaluation instruments are proprietary with MDAC, having been developed by or in coordination with MDAC personnel and therefore not available to other potential contractors. MDAC is the only corporation capable of preparing and delivering a model evaluation package that falls within the parameters required by this project within the necessary time constraints.
- c. This project continually and exhaustively monitors the state-of-the-art in the field, as well as related disciplines. No other entity with the requisite resources and expertise for satisfactory contract completion has been identified.
