This vessel has been strongly involved in narcotics trafficking (large amounts) in the past. Executives of the vessel's company are knowledgeable of its involvement.

Vessel is currently on a "clean run" (purposefully so). It is not involved or planning to be involved with anything before it reaches its destination. The vessel is in communication with other entities.
