The structure or object has technology associated with it. Inside, people work on small objects in front of them.


Blue, green, gold, white, brown are colors associated with the site.



PROTOCOL

JOINT COMMUNICATIONS SERIES

The Joint Communications (JC) series will involve the interaction of our remote viewers acting as senders as well as receivers.

One remote viewer will be designated as the "sender" while the remaining two viewers will be the designated receivers of information during a specific time window set aside for this purpose. The time window will normally be from 1000 hrs to 1045 hrs.

Immediately following the session, the two remote viewers who acted as receivers will finalize their independent summaries with <u>supportive sketches</u>.


The two remote viewers who acted as receivers <u>will then compare</u> <u>their composite findings</u> and agree upon a prioritized listing of key responses to the target.

In all instances, the remote viewers acting as receivers <u>must</u> address the most significant target aspects. These will be identified as a distinct and separate entry in the summary.

Immediately following the session, the <u>sender</u> will also prepare a short summary of his "sending" activities that will reflect areas of concentration including the feeling/sensation/sound aspect associated with the target.

After the four targets in this phase are completed, a <u>target-RV</u> <u>script/sketch</u> judging procedure will occur. All four targets will be placed in random order and analysts will attempt to identify their proper order based on the RV data. This is similar to the procedure used in the December 1992 communication experiment.

<u>Important Note</u>: The sender(s) <u>cannot</u> discuss the target until after the judging process is completed. The two receivers <u>cannot</u> discuss their data with anyone else until after the judging process is completed.
