

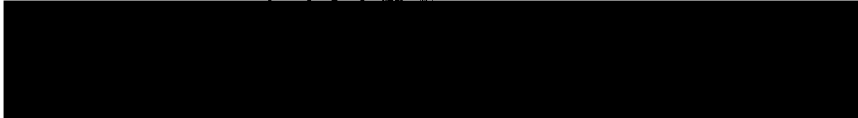

SUBJECT: ARMY POLICY GUIDANCE RE REQUESTS FOR INFO--GRILL FLAME (U)

A. ACSI ELEC MSG 262020Z OCT 79, SAB.

1. (U) REF MSG EST POLICY THAT ALL REQUESTS FOR INFO CONCERNING ARMY PROJECT MUST BE COORDINATED THROUGH HQDA, OACSI. PROVISIONS OF THAT POLICY REMAIN IN EFFECT.
2. (C) PURPOSE OF THIS MSG IS TO REPEAT AND REINFORCE PREVIOUS POLICY. SINCE PROMULGATION OF THE POLICY, AGENCIES OUTSIDE ARMY HAVE CONTINUED TO ENGAGE IN BROKERING BRIEFINGS TO BE GIVEN BY ARMY ACTION AGENCIES, MAKING ARRANGEMENTS DIRECTLY WITH INDIVIDUAL ACTION OFFICERS. THIS HAS CAUSED SEVERAL MAJOR INCIDENTS WHICH REQUIRED CONSIDERABLE EFFORT TO RESOLVE AND UNDO SOME DAMAGE TO THE OVERALL PROJECT. FOR THESE REASONS IT IS ESSENTIAL THAT WE REPEAT THE GUIDANCE TO ALL PLAYERS. WITHOUT EXCEPTION, SHOULD ANYONE, INCLUDING MEMBERS OF CONGRESS, DESIRE AN ARMY BRIEFING, THE REQUESTOR SHOULD BE REFERRED DIRECTLY TO THE OACSI POINT OF CONTACT (DAMI-15R).
