SUMMARY OF INFORMATION

SG1A The target vessel has been identified under the alias of [REDACTED] SG1A
[REDACTED] for purposes of this exercise. [REDACTED] is currently

sailing in an area located immediately south of Florida, and en route to St Augustine, Florida, where is projected to unload illegal contraband in the form of drugs. [REDACTED] is then projected to sail to Savannah, Georgia, where it will unload additional contraband drugs. Contraband drugs unloaded in Savannah are destined for transshipment to Augusta, Georgia. SG1A

SG1A It is anticipated the [REDACTED] will then travel east and then south. It will then sail in a westerly direction through the Florida Keys. The receipt of instructions will then SG1A

SG1A determine if the [REDACTED] makes a port of call in Houston, Texas. In any case, its ultimate destination is California where it is projected to arrived "clean," free of drugs. SG1A

SG1A The names [REDACTED] and variations thereto surfaced phonetically as being associated with the [REDACTED] SG1A

The drugs were packaged in "boxes tied with white string - may even be dropped in (the) water."

The illegal contraband was stored in the "brig" (ship's jail?).
