Dear Mr. Greenewald:

This is a final response to your April 24, 2022 Freedom of Information Act (FOIA) request, a copy of which is enclosed for your convenience. The Office of the Secretary of Defense/Joint Staff (OSD/JS) FOIA Requester Service Center received your request on April 25, 2022, and assigned it FOIA case number 22-F-0863. We ask that you use this number when referring to your request.

The Office of the Under Secretary of Defense for Intelligence & Security, All-domain Anomaly Resolution Office, a component of OSD, conducted a search of their records systems and located 21 pages determined to be responsive to your request. Mr. Paul Plescow, Senior Intelligence Officer, in his capacity as an Initial Denial Authority, has determined that portions of the responsive pages are exempt from release pursuant to 5 U.S.C. § 552 (b)(5), inter- and intra-agency memoranda which are deliberative in nature; this exemption is appropriate for internal documents which are part of the decision-making process, and contain subjective evaluations, opinions and recommendations; and (b)(6), information which, if disclosed, would constitute a clearly unwarranted invasion of the personal privacy of individuals. Please note that we have considered the foreseeable harm standard when reviewing records and applying exemptions under the FOIA in the processing of this request.

In this instance, fees for processing your request were below the threshold for requiring payment. Please note that fees may be assessed on future requests.

Sir, by now you should be close or at your first waypoint on your journey. Hope all smooth so far. This is the first of a daily (Mon-Fri, unless emerging issues require weekend) SITREP. The intent is brevity on the issues just to give you SA on

activities. If you desire additional data/information please tell me which item by number and we will send your detailed response at the appropriate classifications. If you want a different format please let me know.

Highlights from yesterday and today:

**UAP update w/DSD:** Deputy comfortable with our proposal and directed us to draft an unclassified memo for her signature that directs I&S to develop a plan to formalize activities & establish procedures to enhance and structure analysis of the problem set. We are rapidly coordinating the memo in tandem with the UAP report to ensure it can be released simultaneously with the DNI report, which is currently set for release at 1100, Friday, 25 June.

**Counter-Extremism Working Group:** Tara Jones briefed the Deputy on two I&S-lead LOEs, strengthening Insider Threat programs and enhancing social media screening capabilities. Deputy satisfied and supportive of recommendations.

**Fence:** Successful DoD/DNI meeting w/ SAC-D and approval to lift funding fence, Kevin Sherman attended for I&S.

**4-star board:** The joint study team gave the board an in-progress review on the DSD/DNI directed 90 study. Great discussion around the table and the leadership made some recommendation to add to the draft report which will hopefully mitigate problems during coordination. I agreed to make adjustments. We are on track to meet the end of July suspense.

**SWR visit:** I attended the SWR visit with the Deputy and DNI, successful visit. Discussions on an unrelated topic are worth a back brief when you return.

**OSD Management:** Director Administration and Management, Mike Donnelly, is leading effort to determine ownership of former CMO oversight functions. Consensus to keep Intel Oversight as a direct report to DSD and add civil liberties function. No consensus on oversight of Defense Wide Agencies. I&S and other USD reps articulated need to keep direction and control with the PSAs. There will be a meeting to discuss w/ the DSD over the next two weeks. Neil Tipton attended for I&S.

**IMS Vetting:** Garry Reid, in collaboration with Policy, signed a 30 day extension to delay NATO implementation of new vetting standards for International Military Students. CLS and Policy are in final stages of presenting USDP and USDI&S with a joint staff package for SecDef approval of IMS vetting procedures and directed by the NDAA. The package is pending final OGC coordination.

**Media/Congressional interest in firearms accountability:** I&S was tasked to prepare a response to a letter from Sen Blumenthal expressing the Senator's concerns over the recent Associated Press article on loss of Arms, Ammunition, and Explosives. I&S has a draft memo for USDI&S to task components with additional inventory control and reporting requirements; memo is pending OGC coordination. CLS is partnered with the Joint Staff - which was directed by the CJCS - to ensure the Mildeps conduct a 100% inventory of all AA&E.

All meetings internal for I&S leadership tomorrow. Focus of effort is work on the 30 day state of the USD I&S and some of the organizational things you and I have discussed.

Sir, hope all is going well so far. Relatively quiet day here, with all internal meetings. I know the team is helping Todd on some transportation while you are in Japan. Let us know what else we can do for you.

1. **UAP:** We wrapped up rapid coordination and obtained SD concurrence on the DNI classified and unclassified reports this morning. We expect the reports to be released to Congress and the unclassified report to be released on DNI.gov this afternoon. Most importantly, the DSD approved plan moving forward and signed the attached memo. Neill and team are working through the next steps and will be ready with a proposal upon your return.
2. **State of I&S:** I initiated 1v1s today with the DDIs and DRs on alignment to strategy and prioritization. Common threads seem to be stovepipes, lack of strategic goals, mechanisms to track progress, and the need for executive development/management. We will complete the 1v1s early next week and finalize conclusions/recommendations for an improved organizational structure.
3. **36-Star memo:** I will attend the final IPR with the DNI on Tuesday, at which the working group plans to close out its work and propose a governance structure w/in I&S moving forward.
4. **Space Policy:** ISPR is working several space policy issues heading into DC next week, we are generally aligned with Policy's recommendations.
5. **Topics for Monday's SD/Under meeting:** I plan to brief the following topics on Monday, (1) UAP way ahead; (2) 36-Star Memo; (3) International Military Student (IMS) Vetting. If you would like me to bring anything else up please let me know

Sir,

Lex Fridman asked if you'd like to participate in one of his podcasts. The episode would run approximately 2 hours and would be "a relaxed conversation" covering your whole career, from Russian linguistics role (Lex is Russian) to CIA, NSA, USD(I&S), and the new AOIMSG. This would include high-level topics about the nature of security, privacy, intelligence, and how our government works. He said he would only keep content that you like and are proud of in order to highlight positive, inspiring ideas in your work. The podcast would be recorded in Austin, TX, or here in Washington DC. Timing would be based on your schedule. If you wanted to go to Austin we could potentially stop at Goodfellow AFB and meet with the Intel schoolhouse.

In addition to the podcast request he also offered his assistance in the AOIMSG. He wrote: "Research & public-facing communication for AOIMSG: I'd like to ask if I can help in the early stages of forming the AOIMSG in my official role as research scientist at MIT. My work is in AI, robotics, machine learning, and computer vision, so perhaps I can assist on that side of the effort. I can write up an official proposal from MIT if needed. I'm not interested in finances, just to help out on an exciting effort, either in research or in communication. DARPA & DoD has funded many efforts of my research group." If this is of interest I can link him with the AOIMSG team.

Good afternoon. Earlier this afternoon, ODNI delivered the classified and unclassified versions of the UAP Report to the Congressional Defense and Intelligence Committees via CAPNET.

For your awareness, OUSD(I&S)/CA followed suit by sending the following (with attachments)...

"This afternoon, the ODNI provided Congress with its unclassified and classified reports on Unexplained Aerial Phenomena (UAP), as requested by the Senate Select Committee on Intelligence in its report accompanying the FY 2021 Intelligence Authorization Act.



The Department takes UAP seriously, and is committed to improving its observation and reporting of UAP.

To that end, Deputy Secretary of Defense Hicks issued the attached memorandum directing the Under Secretary of Defense for Intelligence & Security to provide her with a plan to formalize the mission currently performed by the Navy's UAP Task Force. FYI, OSD Public Affairs will be sharing the attached statement with the media later this afternoon.

After the Deputy receives and approves this plan, the Department will notify Congress of her decision. In the meantime, Department representatives are available to brief you on DoD equities in the ODNI's UAP report upon your request."

Sir,

Couple of additional data points in case you want to mention at the Unders' meeting in the morning.

28 members, from across both SSCI and SASC is nearly unprecedented for an engagement like this. The team was me, plus General Officer reps from ODNI, USN, USAF, and NORAD.

In addition to 28 members participating, the session went 45 minutes longer than scheduled.

What this indicates (and was very clear from the Q&A from the Members) is continued very high interest from the Senate in understanding what this UAP issue really is.

The Q&A covered the gamut from very tactical to very strategic in nature. The members are looking forward to future engagements (e.g., 90-day update from DNI on collection strategies and the 'technology roadmap' that was offered in the DNI's report), and the DoD's way ahead on formalizing the UAP TF. I did mention that we are working to develop options to respond to the DepSecDef's tasker to us, and look forward to updating them on what DSD ultimately decides.

In terms of atmospherics, the opening comments were fairly pointed ('why have you not done anything yet'), but over the course of the Q&A I think the team successfully grounded them in the where we are and that we have made real progress (standardization of reporting, direction to pilots on what to do in these events, etc.). More to come, it's not unlikely that they will use the FY22 NDAA and approps bills to give us additional direction, and we will begin to see that over the next couple of months.

- The Establishment Memo and Terms of Reference for the Airborne Object Identification and Management Synchronization Group (AIMSG) are out for Principal Coordination, and I expect to have a document for your review and decision next week.
- There will clearly need to be a transition timeline as we establish the AIMSG. The Executive Committee (I&S, DJS and PDDNI) will appoint an interim Director and Deputy for the AIMSG, and the current UAPTF mission and activities will move under the AIMSG until it can be fully staffed.
- I am working to identify the appropriate funding for the AIMSG, but ask for your support in looking across the Department for help to properly resource this mission.
