Subject: Freedom of Information Act (FOIA) Request 2021-001423WP

This letter is in response to your Freedom of Information Act (FOIA) request dated October 17, 2020. You requested copies of all records pertaining to someone flying a jet pack near the Los Angeles International Airport (LAX) on October 14, 2020. Your request has been forwarded to our Air Traffic Division. They will furnish a separate response.

A search for records was conducted at the Los Angeles Flight Standards District Office. Enclosed are copies of documents in our files relative to this request. We are withholding information under Exemption 5 of the FOIA. Exemption 5 allows agencies to withhold opinions, recommendations and analysis under the deliberative process privilege. To allow release of these records would discourage the open and frank discussions between agency employees that are helpful during an investigation and also create confusion in those cases where recommendations and opinions are not adopted. Exemption 5 may be used to protect deliberative, pre-decisional materials, such as advice, opinions, and recommendations rendered by agency staff in the course of reaching a final determination or position on any particular matter under agency consideration.

In addition, information has been redacted and is being withheld from disclosure under Exemption 6 of the FOIA. Exemption 6 of the FOIA protects information that pertains to an individual "the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." When applying Exemption 6, the FAA weighs the privacy interest of an individual against any public interest in the records.

Your request qualifies for the "News Media" fee category, whereby you are not charged for search time, review time, and no duplication fees under the first 100 pages. Under Title 49 Code of Federal Regulations 7.43 (a) (1), there are no fees associated with this request because the cost of processing is less than \$25.00.

As the General Aviation Safety Assurance Deputy Director, I am responsible for this partial denial determination. You may request reconsideration of this determination by writing the Assistant Administrator for Finance and Management (AFN-400), Federal Aviation Administration, 800 Independence Avenue, SW, Washington, DC, 20591 or through electronic mail at: <a href="FOIA-Appeals@faa.gov">FOIA-Appeals@faa.gov</a>. Your request for reconsideration must be made in writing within 90 days from the date of this letter and must include all information and arguments relied upon. Your letter must state that it is an appeal from the above-described denial of a request made under the FOIA. The envelope containing the appeal should be marked "FOIA Appeal."

#### Hi Mike,

Here is the initial report of the latest Jetpack sighting by China Airlines inbound to LAX, and my request to Air Traffic for Primary and Secondary radar targets to see if we could identify a track or location of the object. Here's an excerpt from Air Traffic's response with a link to the animation file based on FAA radar data, and some clarification provided by Air Traffic personnel in the email exchange:

I pulled the raw radar data I had for this area and did not seen any conclusive primary tracks. The reporting aircraft, CAL006, was NE of LAX at 2043Z. I do see a few primary targets but they don't develop into a track. Attached is a .mov file I made showing all targets as CAL006 enters the LAX area. I started it around 2037Z and ended it when the aircraft was touching down at LAX.

Ian,

The blue dots are primary targets, the red dots are secondary beacon targets, the greed dots are reinforced beacon targets, and the purple targets are ADS-B. Since this is raw radar multiple radars are hitting a lot of the targets at the same time. For example the CAL006 target is ADSB and you can also see beacon only and reinforced beacon hits and occasionally a primary hits, that is why you see a cluster of targets moving with the data block. Short range radars update faster than long range radars so this is why you see different target types that are not timed the same.

Good questions! I apologize, I fell into SAR mode when I sent the data file out.

Ed,

Spoke with the FBI this morning. They have not interviewed the individual who posted the YouTube video showing flight of a 1:1 scale UAS appearing to look like a human jetpack. The individual lives in Germany and hasn't been to the United States since 2011. They have interviewed the person who posted the short 6 second video, but that has not lead to anything. Interviews have also been conducted with all the pilots connected to the reported sighting. The only creditable report was the first sighting. The pilot was shown the 1:1 scale video and stated it looked a lot like what he saw. The other three events have pilots reporting to ATC they saw a jetpack, but when interviewed by the FBI, the pilots could not confirm what they saw. One stated he saw what looked like a motorcycle in the air and the other two stated it was something shiny. The latest report, CA006 pilots initially denied telling ATC they saw a jetpack, they insisted it was ATC who suggest it to them. The pilots recanted their story only after the FBI told them they listened to their communication with ATC and heard the pilots say jet man or jetpack first. Once confronted the pilots stated they were not sure what they saw, but remembered something about the "jetpack" sighting from last month so that is why they reported and agreed to when questioned by ATC. They went on to say they only saw it for a two (2) seconds, it was shiny, and possibly about 2 meters in size.
