

I am writing on behalf of People for the Ethical Treatment of Animals, Inc. (PETA) to follow up with PETA's recent complaint regarding a death threat that was e-mailed to a dba Greater Wynnewood Exotic Animal Park, at PETA staff member by 25803 N. County Road 3250, Wynnewood, OK 73098, and to provide the FBI with addition information, including a second threat of violence that bosted to his public Facebook page on June 16, 2017, directed at We believe that is currently in Las Vegas, Nevada. On June 16, 2017 posted a photo of on his Facebook page, with the following threat of violence: "Does this bitch seriously think she's any match for me? bring it on. When it's done and over i'll live stream 15 tigers eating Think I'm kidding? ask people that know me, I never rest when fucked with. go dig up that box, I might need its contents soon." See Exhibit 1. In the posts' comments states in reference to "I'm willing to die for my beliefs, I wonder if she is?" See Exhibit 1. This threat comes after a series of posts about PETA. including one that stated: "If you dare threaten us or our animals, it will result in bad consequences for you.... you might want to stop now. This is your only warning!" See Exhibit 2.

Please immediately investigate this individual for his intimidating and coercive threats of violence that are a serious expression of intent to harm. Thank you for your prompt attention to this important matter. Please do not hesitate to contact me if you have any questions.


