WILLIAM WARD PIGMAN

Rerep SA CLARK E. LOVRIEN, dated February 8, 1949 at Milwaukee.

On page five of reference report, PIGMAN relates an incident wherein he forwarded to a woman in Moscow, Russia a shipment of household goods and other items at the request of the woman's husband who is a professor acquaintance of PIGMAN's at Leipzig University, Germany. It will be noted that at the time of interview, PIGMAN was anxious that this information be furnished to the FBI, yet he would not let the letter and the license forms out of his possession for the purpose of photostating. By letter dated February 16, 1949, PIGMAN advised this office that he had been unable to make satisfactory arrangements to have these items photostated in Appleton, Wisconsin and offered to come to Milwaukee where this could be done in his presence.

PIGMAN appeared at the Milwaukee Office the morning of February 23, 1949 and in his presence photostatic copies of these documents were made. Upon his own suggestion, PIGMAN wrote his name, date, and a number on the face of each original before it was photostated. He then initialed and dated the negatives of each photostat on the back thereof.

There are being enclosed with the copy of this letter to New York Office the negative photostats and one positive copy from the negative of each of the following documents in the order as numbered by PIGMAN:

1. A letter from Sears Roebuck and Company, Philadelphia, Pennsylvania, dated December 7, year not given, and addressed to Dr. WARD PIGMAN, 2006 North Stratford Street, Arlington, Virginia.

2. The reverse side of letter #1.

3. A document in Russian described in #1 as "official license" form bearing serial number 91777 at the top of the document.

4. Same as #3 but bearing serial number 91778.

5. Same as #3 but bearing serial number 91779.
