At 11:30AM she will depart for the [REDACTED] Rye, NY from there she will be attending a luncheon at the Rye Golf Club at 12:00, returning to the [REDACTED] residence after the luncheon. At 5:00PM, she will depart for the Rye Country Day School to attend their Graduation Ceremony where she will be the guest speaker. After the Graduation will depart for La Guardia Airport.

On 12/10/91, SA [redacted] was contacted by the Fairfield Department of Public Safety (FDPS), Fairfield, California, concerning a person, who had made a threat against the president's wife, Barbara Bush.

[redacted] Dispatcher, FDPS, had received approx. six or seven telephone calls at FDPS dispatch. A female caller, on each call, had said "Tell George Bush that his wife is going to die!" [redacted] said that these calls were between 4:15-4:30 p.m. [redacted] contacted the Pacific Bell (PB) telephone company in an attempt to identify where the telephone calls were originating from.

The PB operator said that the person was calling from 427-0804 and 427-0805, which were a non-coin telephone. This meant that the person was not using a pay telephone. [redacted] advised that the caller sounded possibly like a black female, 19's to early 30's, sluggish voice as if the person was high on drugs and sounded "crazy". [redacted] advised that the FDPS was not doing anything on the calls but wanted the FBI to know about what was happening.

A criss/cross check was made on the two phone numbers with negative results. SA [] called the 427-0804 phone number and spoke to the Motel 6, front desk clerk. The clerk said that the Motel 6 was located on Megellan Road in Fairfield. The clerk advised that their telephone number was 427-0800 but they had numerous telephones in the individual motel rooms and each phone had a different phone number.

An attempt was made to contact the Secret Service in Sacramento to inform them of the threat. A message was left with their answering service, who advised that she would contact an Agent.

SA [] went to the Motel 6 at 4353 Megellan Road and contacted the Motel Manager. [] advised that they have about 50 telephone numbers for the Motel. These numbers are not assigned to any telephone and works on a rotary type base through PB. They could not tell which number was used by which room. [] advised that all local phone calls are free and only toll calls would have a record as to what room the calls came from. The calls to the FDPS dispatcher were local calls.

[] was given the description of the possible caller. [] advised that in room #231, they have a black female that has been making constant calls to the FDPS. [] said that officers of FDPS had already been at room #231 at about 6:30 p.m. due to a call from the female. [] said that the female does seem to be mentally incompetent due to her actions and behavior. The FDPS officers had advised him that they could not take her away unless she was a threat to herself or others. [] clerk, also advised that she had received a call from the female's doctor in San Diego, California, who advised her that [] was mentally unstable. [] did not know who the person was that called and could not remember the exact date.

A check was made of the Motel 6 room slips and it showed that #231 was being used by [] San Diego, CA. with license [] She was described, by the motel personnel, as a black female, 50 years plus, 5'3-4" tall, 100-110 pounds, thin build, with reddish-blond hair.

SA [] contacted the FDPS and Lieutenant [] responded to the Motel 6. [] advised that his officers and himself had spoken to the female, in room #231, on a few occasions. [] said that on every visit to the female made like she could not speak English and started speaking fast rate. She sounded as if she was speaking Spanish. [] said that the female appeared to be mentally unstable but they could not take her to mental health unless she was a danger to herself or others. I informed [] that I wanted to attempt to interview the female concerning the threats. We had no evidence other than her possibly matching the description of the caller by

the FDPS dispatcher.

SA [] and Lt. [] went to #231 and knocked on the door. A middle-aged female responded to the knocks. SA [] identified himself by use of his credentials and verbally saying Special Agent with the FBI. The female was advised to why the FBI and police was there. The female allowed them into her hotel room. The female provided a California Driver's license [] which identified her as [] [] was advised that someone had called the FDPS dispatcher and had made threatening comments toward the President's wife, Barbara Bush. [] denied that she had made any telephone calls and said that she had been sleeping. (The motel manager had told us that [] had been using her phone before the FBI arrival.)

[] then said that Khadafi would get SA [] and Lt. [] and that they would be in trouble. She said that she was from Egypt and then started speaking in gibberish which was consistent with what Lt. [] had said. [] would not provide any information on herself and became argumentive and defensive. [] said that she was not part of the USA and that everyone was going to die. She did not care about the USA, the government or the people. She kept on talking about Egypt and her dislike for America. She would speak English then start speaking in gibberish. [] was informed that if it was her or someone else who made the telephone calls, they could be arrested for threatening the President or his family. [] constantly denied making any telephone calls. [] was very defensive and loud. She then asked us to leave her room as we were already leaving.

It appears that [] is somewhat mentally unstable. SA [] checked with the Suisun City Police Department, Suisun, Ca. and with FDPS and found that [] had numerous 5150 (mentally unstable or incompetent) contacts. SA [] of the Secret Service (S/S) was contacted on 12/11/91 concerning [] SA [] provided information that the S/S had contacts with [] on three occasions in 1986. SA [] requested that any investigation, which was conducted, be forwarded to the S/S in Sacramento.

SA [] contacted SA [] at FBIHQ, VCU, concerning [] and her threats. After being apprised of the facts, SA [] requested the appropriate paperwork be submitted for documentation and also to be forwarded to the S/S.

AN ATTEMPT WAS MADE TO CONTACT THE SECRET SERVICE IN SACRAMENTO TO INFORM THEM OF THE THREAT. A MESSAGE WAS LEFT WITH THEIR ANSWERING SERVICE, WHO ADVISED THAT SHE WOULD CONTACT AN AGENT.

SA [] WENT TO THE MOTEL 6 AT 2353 MEGELLAN ROAD AND CONTACTED THE MOTEL MANAGER. [] ADVISED THEY HAVE ABOUT 50 TELEPHONE NUMBERS FOR THE MOTEL. THESE NUMBERS ARE NOT ASSIGNED TO ANY TELEPHONE AND WORK ON A ROTARY TYPE BASES THROUGH PB. THEY COULD NOT TELL WHICH NUMBER WAS USED BY WHICH ROOM. [] ADVISED THAT ALL LOCAL PHONE CALLS ARE FREE AND ONLY TOLL CALLS WOULD HAVE A RECORD AS TO WHAT ROOM THE CALLS CAME. THE CALLS TO THE FDPS DISPATCHER WERE LOCAL CALLS.





[redacted] advised that the caller sounded possibly like a black female, late 20's or early 30's, with a sluggish voice as if she were high on drugs, and sounded "crazy". [redacted] advised that they did not get any information from PB but determined that the FBI should be called. [redacted] said that FDPS was not doing anything on the threatening telephone calls, but wanted the FBI to know what was happening.

Due to the fact that no other information had been received by FDPS, it was determined that further investigation was warranted to determine the source of the telephone calls.

SA [redacted] went to the Motel 6 at 2353 Magellan Road, Fairfield, California, and contacted the motel manager, [redacted]. [redacted] advised that they have approximately 50 telephone numbers for the motel, and that there was no way for him to tell which telephone had what telephone number. The numbers are not assigned to any telephone and work on a rotary-type basis through PB. They could not tell which number was used by which room. [redacted] advised that all local phone calls are free from the rooms and only toll calls would have a record showing what room the calls were made from. The calls to the FDPS dispatcher were local telephone calls. 
