

FBI FOIPA Addendum

As referenced in our letter responding to your Freedom of Information/Privacy Acts (FOIPA) request, the FBI FOIPA Addendum provides information applicable to your request. Part 1 of the Addendum includes standard responses that apply to all requests. Part 2 includes standard responses that apply to requests for records about individuals to the extent your request seeks the listed information. Part 3 includes general information about FBI records, searches, and programs.

Part 1: The standard responses below apply to all requests:

- (i) **5 U.S.C. § 552(c).** Congress excluded three categories of law enforcement and national security records from the requirements of the FOIPA [5 U.S.C. § 552(c)]. FBI responses are limited to those records subject to the requirements of the FOIPA. Additional information about the FBI and the FOIPA can be found on the www.fbi.gov/foia website.
- (ii) **Intelligence Records.** To the extent your request seeks records of intelligence sources, methods, or activities, the FBI can neither confirm nor deny the existence of records pursuant to FOIA exemptions (b)(1), (b)(3), and as applicable to requests for records about individuals, PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(1), (b)(3), and (j)(2)]. The mere acknowledgment of the existence or nonexistence of such records is itself a classified fact protected by FOIA exemption (b)(1) and/or would reveal intelligence sources, methods, or activities protected by exemption (b)(3) [50 USC § 3024(i)(1)]. This is a standard response and should not be read to indicate that any such records do or do not exist.

Part 2: The standard responses below apply to all requests for records on individuals:

- (i) **Requests for Records about any Individual—Watch Lists.** The FBI can neither confirm nor deny the existence of any individual's name on a watch list pursuant to FOIA exemption (b)(7)(E) and PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(7)(E), (j)(2)]. This is a standard response and should not be read to indicate that watch list records do or do not exist.
- (ii) **Requests for Records about any Individual—Witness Security Program Records.** The FBI can neither confirm nor deny the existence of records which could identify any participant in the Witness Security Program pursuant to FOIA exemption (b)(3) and PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(3), 18 U.S.C. 3521, and (j)(2)]. This is a standard response and should not be read to indicate that such records do or do not exist.
- (iii) **Requests for Confidential Informant Records.** The FBI can neither confirm nor deny the existence of confidential informant records pursuant to FOIA exemptions (b)(7)(D), (b)(7)(E), and (b)(7)(F) [5 U.S.C. § 552 (b)(7)(D), (b)(7)(E), and (b)(7)(F)] and Privacy Act exemption (j)(2) [5 U.S.C. § 552a (j)(2)]. The mere acknowledgment of the existence or nonexistence of such records would reveal confidential informant identities and information, expose law enforcement techniques, and endanger the life or physical safety of individuals. This is a standard response and should not be read to indicate that such records do or do not exist.

Part 3: General Information:

- (i) **Record Searches and Standard Search Policy.** The Record/Information Dissemination Section (RIDS) searches for reasonably described records by searching systems, such as the Central Records System (CRS), or locations where responsive records would reasonably be found. The CRS is an extensive system of records consisting of applicant, investigative, intelligence, personnel, administrative, and general files compiled by the FBI per its law enforcement, intelligence, and administrative functions. The CRS spans the entire FBI organization, comprising records of FBI Headquarters, FBI Field Offices, and FBI Legal Attaché Offices (Legats) worldwide; Electronic Surveillance (ELSUR) records are included in the CRS. The standard search policy is a search for main entity records in the CRS. Unless specifically requested, a standard search does not include a search for reference entity records, administrative records of previous FOIPA requests, or civil litigation files.
 - a. *Main Entity Records* – created for individuals or non-individuals who are the subjects or the focus of an investigation
 - b. *Reference Entity Records*- created for individuals or non-individuals who are associated with a case but are not known subjects or the focus of an investigation
- (ii) **FBI Records.** Founded in 1908, the FBI carries out a dual law enforcement and national security mission. As part of this dual mission, the FBI creates and maintains records on various subjects; however, the FBI does not maintain records on every person, subject, or entity.
- (iii) **Foreseeable Harm Standard.** As amended in 2016, the Freedom of Information Act provides that a federal agency may withhold responsive records only if: (1) the agency reasonably foresees that disclosure would harm an interest protected by one of the nine exemptions that FOIA enumerates, or (2) disclosure is prohibited by law (5 United States Code, Section 552(a)(8)(A)(i)). The FBI considers this foreseeable harm standard in the processing of its requests.
- (iv) **Requests for Criminal History Records or Rap Sheets.** The Criminal Justice Information Services (CJIS) Division provides Identity History Summary Checks – often referred to as a criminal history record or rap sheet. These criminal history records are not the same as material in an investigative “FBI file.” An Identity History Summary Check is a listing of information taken from fingerprint cards and documents submitted to the FBI in connection with arrests, federal employment, naturalization, or military service. For a fee, individuals can request a copy of their Identity History Summary Check. Forms and directions can be accessed at www.fbi.gov/about-us/cjis/identity-history-summary-checks. EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552


- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;
- (b)(6) personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;
- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552a

- (d)(5) information compiled in reasonable anticipation of a civil action proceeding;
- (j)(2) material reporting investigative efforts pertaining to the enforcement of criminal law including efforts to prevent, control, or reduce crime or apprehend criminals;
- (k)(1) information which is currently and properly classified pursuant to an Executive order in the interest of the national defense or foreign policy, for example, information involving intelligence sources or methods;
- (k)(2) investigatory material compiled for law enforcement purposes, other than criminal, which did not result in loss of a right, benefit or privilege under Federal programs, or which would identify a source who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

THE ARTICLE STATED ANTI-BRITISH FEELINGS ARE RUNNING HIGH AS A RESULT OF WELL PUBLICIZED INJUSTICES INFLICTED ON THE BIRMINGHAM SIX BY THE CORRUPT ENGLISH JUDICIAL SYSTEM AND THE RECENT RASH OF BRUTAL MURDERS OF UNARMED IRISH NATIONALISTS IN THE SIX COUNTIES BY LOYALISTS DEATH SQUADS. She's not our queen, but before we're through with her, she'll probably think she is. Two centuries after George III lost the colonies, Queen Elizabeth II is in danger of winning them back.

Or so it might seem for all the carryings-on over the royal road show starring her and her husband, the Duke of Edinburgh, that begins tomorrow. For the next three days in Washington, and six after that in Florida and Texas, Britain's 63rd monarch in 1,000 years will be wined, dined, gifted, toasted, curtsied, filmed, quoted, saluted, satired, cheered and doubtless even jeered.

She is, after all, the closest Americans will ever get to a genuine queen of their own.

After two years in production—George Bush first invited her when she had him to lunch at Buckingham Palace in 1989—the spectator sport of Royals Watching now gets underway in earnest. Commoners should be able to catch a glimpse of the queen outside her public stops and along her motorcade route. And recession-weary Americans

can shamelessly indulge themselves in a fantasy world of crowns, castles and red carpets.

This great-great-great-great-granddaughter of Britain's last monarch to rule us is no stranger in these parts. She's been to Washington three times (1951, 1957, 1976) and to the West and Midwest five others (1959, 1983, 1984, 1986, 1989). What sets this visit apart is that for the first time in America's 384-year history as a British colony that became a nation, a British monarch will appear before the governing body to address its members.

Both the U.S. Congress and Buckingham Palace would be loath to suggest the delay had anything to do with 1776, when the Brits lost a major foothold in the New World, or 1812, when they tried to recapture it. That the visit follows the latest instance of Anglo-American unity in the Persian Gulf War seems to be a happy coincidence.

Though basically a shy woman not known for her public speaking, the 65-year-old queen is described as "looking forward" to the occasion. The palace predicts a stellar performance.

"When you have two great democracies like ours, and a head of state with such long experience on the throne speaking about our cooperation as allies, you'll be moved to hear what she has to say," her spokesman said.

Her schedule would give even George Bush pause. In the 72 hours she spends in Washington she'll make 18 announced appearances.

In Washington, she'll bed-and-breakfast at Blair House in a suitably majestic five-room, two-bath suite that includes a separate-but-almost-equal spouse's bedroom abloom with flowered wallpaper and matching curtains—if Prince Philip wants it.

Across Pennsylvania Avenue at the White House tomorrow, placecards will await her and Philip at lunch after the arrival ceremony on the South Lawn. (At her own dinners, the queen is the only person *without* a placecard. "She knows where she sits," an aide once said.) Before she leaves for Arlington National Cemetery, she'll plant a tree and bestow upon George Bush the Winston Churchill Foundation Award recognizing his commitment to Anglo-American relations. Since it isn't her award, getting her to present it is something of a coup. "The next time, they'll have to get God," Churchill's grandson and namesake said recently.

For the state dinner in her honor a few hours later, 130 of Washington's most official and the Bushes' most friendly will be waiting to meet her. She's aware of who's invited but avoids any kibitzing over the guest list—or so they say—preferring to operate on the when-in-Rome principle.

Her arrival at the White House and entrance into the State Dining Room later will be heralded by the U.S. Marine Band playing "Orb and Sceptre" by William Walton, the work commissioned for her coronation in 1952. "She'll know it," said Col. John Bourgeois, the band's director who arranged the chamber orchestra version.

There will be no cutesy novelty songs insinuating sexy lyrics, as happened in 1976 when the Captain and Tennille sang "Muskrat Love" before a throng that included Alice Roosevelt Longworth. The Bushes are relying on a proven winner, soprano Jessye Norman, who wowed Francois Mitterrand, his guest George Bush and a television audience of millions on the 200th anniversary of the French Revolution two years ago in Paris.

Whether Bush would ask the queen to dance is a state secret, though the odds are against it. The last time she danced with a U.S. president she probably regretted it. In 1976, Gerald Ford led her onto the dance floor at the very moment the Marine Band, playing a Rodgers and Hart medley, glided into "The Lady Is a Tramp."

"It's long been removed from the repertoire," said Bourgeois.

Wednesday morning, while Prince Philip, a captain-general in the Royal Marines, visits Quantico Marine Air Station, the queen, accompanied by Mayor Sharon Pratt Dixon and Barbara Bush, will visit the newly opened Richard England Clubhouse in Northeast Washington. They'll watch a 10-minute demonstration of double-dutch rope jumping, basketball and cheerleading by members of the Police Boys and Girls Club. At the nearby Marshall Heights community development program, Alice Fra-

zier, 65, will be waiting to show her around the first home she's ever owned.

"I might not have a palace like her," Frazier said, "but it's a palace to me."

Just before noon at the Sheraton Washington Hotel, the queen will give a reception for 250 reporters. She's not without her motives.

"The Queen and the Duke of Edinburgh like to have an opportunity early in the programme when they go overseas to meet representatives of the media covering the visit," says a note accompanying presentation cards. "This reception is intended as an informal, social occasion and guests are reminded that conversation at the reception is regarded as private, entirely off-the-record and not for use in the media."

Don't blame the queen, the British Embassy tells reporters who complain about being left off her invitation list. "We tell them to take it up with their news organizations since we asked them to submit the names," said an embassy source.

From there, the royal couple goes on to the Library of Congress for lunch in the newly restored Thomas Jefferson Building with 300 guests, including Jessica Tandy, Angela Lansbury, Richard Attenborough, David Attenborough and Martin Scorsese. Everybody will be celebrating "The Great British Picture Show," a three-week festival of British film and television, but also dining on cuisine Jefferson himself liked to serve, painstakingly researched at Monticello.

In mid-afternoon Wednesday, it's garden party time, a tradition begun by Queen Victoria so she could meet her own kind. In foreign climes it's more a chance for Victoria's great-great-granddaughter to meet the natives. The embassy denies that a privileged few of the 1,800 invited guests will be pre-selected and told to stand in a particular spot in the embassy garden to await a royal introduction.

"What happens is that the ambassador or others may see people in the crowd they want her to meet and bring them forward then. Or the queen may simply stop of her own accord," said an embassy official.

And now does one act, dress and talk in the presence of this woman?

"Perfectly naturally," said the official. "There are certain myths that are not true—that you have to wear hats or gloves, that you have to curtsy. If she does speak to you, she'll be knowledgeable and ask sensible questions."

"She puts you at ease by focusing on you, unlike some people in Washington who are constantly looking over your shoulder," said Anne Richardson, whose husband, Elliot, was U.S. ambassador to the Court of St. James's in 1975.

By the same token, said Selwa Roosevelt, former U.S. chief of protocol, "she has a dismissive way that lets you know that when she's finished, she's finished. She knows how to be queen."

She also knows how to please crowds. The queen is "very keen about seeing something of the country, the people and the way of life," said an embassy source. Just as she wanted to see Bloomingdale's when she went to New York in 1976, she sent word that she wanted to see a baseball game this time around. She'll get her wish Wednesday night when Bush takes her to the Baltimore Orioles-Oakland Athletics game in Baltimore.

"I can't think of anybody better than having the former starting varsity first baseman of the Yale team at her side to explain the intricacies of the American national pastime," said Chief of Protocol Joseph V. Reed, a longtime friend of Bush's.

On Thursday, the royal pair goes to the Folger Shakespeare Library to see exhibits and watch part of the children's festival before going on to the Capitol for the queen's address to the joint meeting of Congress. They'll join House Speaker Thomas S. Foley and his other guests for lunch in Statuary Hall, then the queen and Philip will head for Mount Vernon, home of a distant relative.

Though George Washington was a Virginian by birth and never set foot in England, his great-grandfather left there in 1659. Through him, Washington and Elizabeth share a common ancestor, King Edward I, who is also an ancestor of George Bush's.

It all makes for a cozy time, when Bush and the queen reunite Thursday night at her reciprocal dinner for him and Barbara Bush at the British Embassy. Friday morning, after attending a short service in the Washington Cathedral, the Defender of the Faith heads to Andrews Air Force Base for points south.

The Royal Retinue, With Ladies and Gents in Waiting

Presidents have handlers. Rock stars have roadies. If anyone deserves an entourage, it's Elizabeth the Second, by the Grace of God, of the United Kingdom of Great Britain and Northern Ireland and of her other Realms and Territories, Queen, Head of the Commonwealth, Defender of the Faith.

What—you expected her to schlep the tiaras herself?

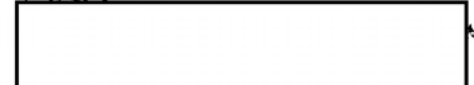
No way. When the Concorde touches down at Andrews Air Force Base tomorrow, the queen and her consort will be accompanied by about 40 royal retainers. Impressive by modern-day standards, but nothing compared with King Henry VIII, who took 4,500 men along to meet Francis I of France in 1520.

"Remember, this is a state visit with two very close allies," said one official from Buckingham Palace. "Its importance is of the very highest level."

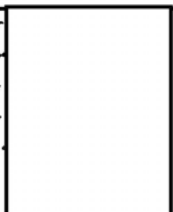

The queen's party will likely include the master of the royal household, two ladies-in-waiting, two private secretaries, an equerry, two dressers, two maids, her hairdresser, the press secretary, the captain of the queen's flight, a physician, two detectives, six footmen, and a secretary and valet for Prince Philip.

Their task, honed from hundreds of years of pomp and ceremony, is to keep Her Majesty's trip free from the embarrassing glitches that plague your everyday tourist—such as lost luggage.

(Speaking of luggage, they will bring anywhere from one to six tons for the 10-day visit, including the queen's two standing wardrobes on wheels, portable chest of clothes, leather trunks and a special trunk for the state gown.)

Mostly, however, they wait—hovering in the background while the queen smiles, waves, gazes admiringly at a new building, listens to long, boring speeches or gives short, boring speeches.

Of those who stand and wait, the most visible are the queen's two senior ladies-in-waiting. One is Lady Airlie, 57, the American-born debutante Ginny Ryan, who has served since 1973. (Lady Airlie is married to Lord Airlie, also known as the lord chamberlain, the most senior member of the royal household responsible for everything on the domestic side of all five royal residences.) The second lady-in-waiting is Kathryn Dugdale, 67, who has worked for the queen since 1956.

"They carry the flowers, the messages and little gifts from the crowd," says Margaret Holder, a writer for *Royalty* magazine who has been following the Windsor family for 10 years. "They're all personal friends of the queen she can talk to in the limousines."

The private secretaries—Sir Robert Fellowes (who is married to Princess Diana's sister, Jane) and Sir Kenneth

Scott—will handle the scheduling details of the visit.

The queen's equerry, a military aide drawn from one of the three armed services, attends her on all official and ceremonial occasions, while plainclothes detectives serve as bodyguards. In addition, there are security men dressed as workmen, street cleaners and guests at the events.

The detectives carry cash in case something catches the royal eye. The contents of the royal purse are a closely guarded secret, but according to Holder, it contains Cyclax Jubilee Pink lipstick, a gold powder compact, smelling salts, reading glasses, a lace hankie, a dog whistle (her beloved Corgis have to stay at home; the whistle is to be used on any unruly American mutts she might encounter), and treats for horses.

No passport, though—it's not required anywhere in the world. And no keys—all doors are opened for her. She's never carried a key in her life.

British Foreign Secretary Douglas Hurd will join the queen on this visit, as will her racing manager, Lord Caernarvon, who shares the queen's passion for horseflesh.

"He is the queen's closest, closest friend," says Holder. "He often shares her TV dinners at Buckingham Palace, and they talk about the day's racing and the progress of her horses." (Lady C., by the way, is the former Jean Margaret Wallop, sister of Sen. Malcolm Wallop of Wyoming.)

Royal chefs from Britannia, the queen's 412-foot yacht staffed by a crew of 254, will meet up with the party for the Miami leg of her visit. Her bags, however, always include Earl Grey tea, shortbread, fruitcake and jam for snacks; sausages, presumably for the staff; and barley sugar, a hard candy that she has enjoyed since she was a child.

Her Majesty's hairdresser, Charles Mostyn, keeps the royal coif in order, and the two dressers keep the royal wardrobe in perfect condition—pressing, laying out and coordinating all her outfits. For a six-day state visit to Japan, the queen brought 30 dresses, 40 pairs of 6½AA shoes, 15 hats and four tiaras. This trip is expected to exceed that: At

least two outfits have been prepared for each public appearance, and each dress was selected to retain the royal dignity—skirts can be neither too tight for getting out of limousines nor too loose lest they blow up on windy days.

The queen always carries mourning clothes and black-edged note paper while traveling in case of a royal death. While in Kenya in 1952, Elizabeth received news that her father had died and that she had ascended to the throne.

According to a palace official, the queen will not appear in full state robes, which are used only for certain traditional occasions, such as the opening of Parliament. Ditto for the crown jewels, which do not travel outside Britain.

But the queen, who is the richest woman in the world, has a fabulous personal collection of jewelry—which catapults even the dowdiest ensemble into a category of its own. "She always wears great clunking jewels that hang down past her neckline," says Holder. The queen also owns about 20 tiaras, and often wears a different one for each formal event during her tours.

The palace keeps mum about the rest of her personal luggage, but the queen reportedly never travels without:

- A white kidskin toilet seat. "No one's ever seen it, but it's very possible," says Holder. "The thing is, every toilet she ever sits on is scrupulously cleaned—if not newly built. If it's true, it must be carried by a lady-in-waiting in a case."

- A hot-water bottle.

- 50 pints of HIV-tested matching blood plasma, now standard procedure for all the royal family.

- A silver monogrammed tea kettle and matching tea canister.

- Several crates of Malvern bottled water.

- Cyclax All-Day Skin Firmer.

- 35mm cameras for personal photographs.

- Pine soap and lemon shampoo.

- Duck-feather pillows.

- Framed family photos.

- Crossword puzzles. The queen has been observed finishing a puzzle moments before a speech to Parliament.

- And umbrellas. Of course.

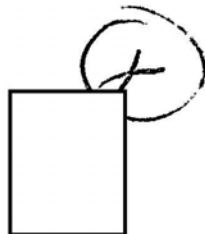

A National Park Service helicopter pilot found the wreckage while checking a reported forest fire, Deputy Pribil said. The crash apparently occurred about 1:30 p.m. local time, he said.

In 1989, 10 persons died when a sightseeing flight crashed into a hill after an aborted landing about five miles south of the canyon.

In 1988, Federal Aviation Administration officials and the Interior Department had changed flight paths over and near the canyon in response to a June 1986 midair collision between a sightseeing plane and a helicopter that killed 25 persons.

Although the weather was clear that day, neither pilot saw the other. The National Transportation Safety Board later said an April 1986 decision by helicopter companies to shift flight routes was a contributing cause.

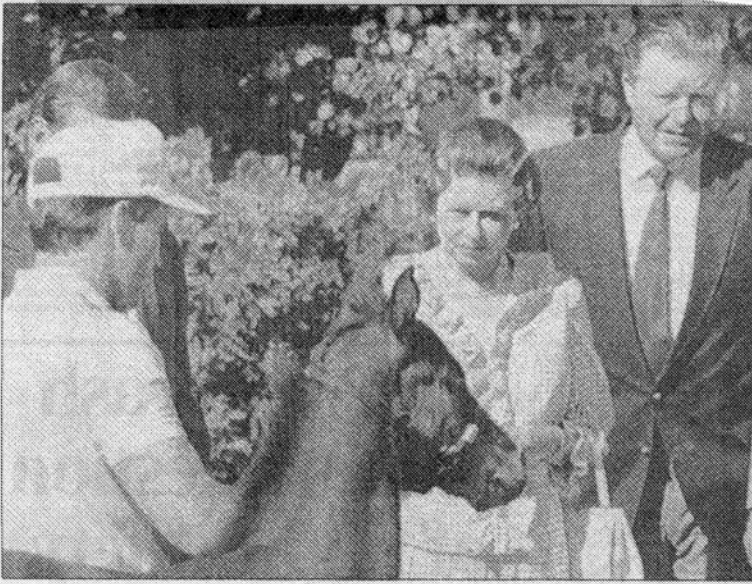

Norman, Alamo, Orioles fit into queen's Southern sweep

Queen Elizabeth II is planning a little all-American fun on her ninth visit to the United States: She'll meet "Storain" Norman Schwarzkopf, eat popcorn at a baseball game and remember the Alamo.

But the queen's visit also will have a formal side.

She'll address Congress — she's the first British monarch to do so — visit a housing project in the nation's capital, tour George Washington's home at Mount Vernon and host a garden party.

Because the queen and her husband, Prince Philip, are the guests of President Bush and his wife, Barbara, the state visit will include a White House dinner and a reciprocal event at the British Embassy.

The closely guarded invitation lists for those parties have kept Washington's social set on tenterhooks for weeks. Bruised egos have already surfaced.

Evangeline Bruce, the doyenne of Washington society and widow of David K.E. Bruce, the former U.S. ambassador to Britain, for example, was excluded from the black-tie sit-

down dinner at the embassy.

The queen is using her official trip — she arrives today for nine days — to get to know America better. After four days in Washington, she'll head to Florida and Texas.

"If you look at the queen's previous visits, there is a clear gap in the southeast quadrant from Texas to Florida," said Michael Price, a spokesman at the British Embassy. "She is going there because she has not been there before, and secondly because these are very important states with fast-growing populations."

Because the queen is the queen, she presumably can go anywhere she wants — and meet anyone she wants. That includes Gen. Schwarzkopf, the American hero of the Persian Gulf war.

The general will be on hand to greet the queen when she arrives at MacDill Air Force Base in Tampa, Fla., headquarters for the U.S. Central Command. Other stops on her itinerary are Miami and, in Texas, Austin, Dallas, Houston and San Antonio, home of the Alamo.

At the end of her official trip, the

queen, still an avid horsewoman at age 65, will travel to Kentucky to see her brood mares. Her husband will return to England.

Buckingham Palace has refused to divulge details of the Kentucky leg of the trip, saying it will be a private affair. In the past, however, the queen has visited Will Farish, a wealthy oil man who entertains Mr. Bush at a turkey shoot every year.

In Washington, the queen will mix formality with fun.

On the floor of the House, she'll deliver a speech on the British-American relationship that "will be short but substantive," Mr. Price said.

The queen will get a crash course in the Great American Pastime — baseball — when she attends a Baltimore Orioles game with Mr. Bush. Baseball is as foreign to the British as cricket is to Americans.

The queen's last official visit was in 1983 when she ate lunch with then-President Reagan and his wife, Nancy, at their ranch in the mountains outside Santa Barbara, Calif. That visit was marred by a freak storm that pounded California.

FMC agrees to ban on pesticide

Carbofuran blamed
for eagle deaths

FMC Corp. agreed yesterday to stop selling a crop pesticide in Maryland and nine other coastal states that has been blamed for the deaths of more than a dozen bald eagles in the Chesapeake Bay region.

The U.S. Environmental Protection Agency negotiated a total ban on sales, effective Sept. 1, in Maryland and other areas where there are breeding grounds and crucial habitat for bald eagles and migratory birds.

The company negotiated a settlement with the EPA that calls for a three-year phasing out of the use of carbofuran granules nationwide.

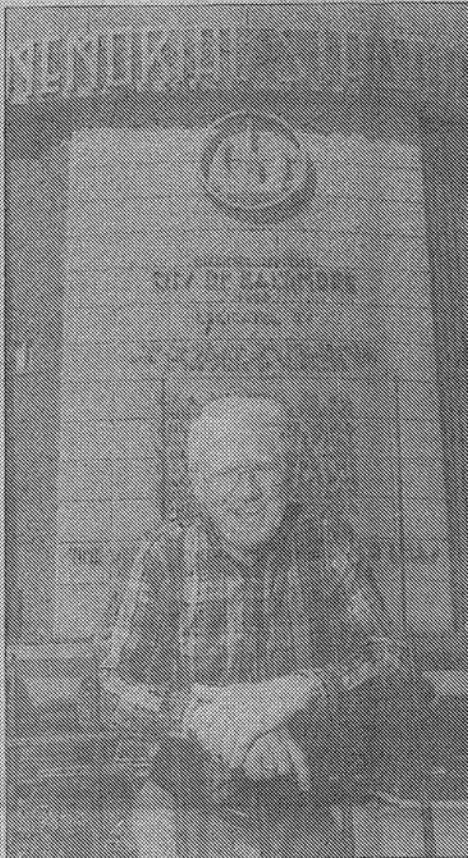
The EPA had proposed banning carbofuran two years ago and was on the verge of announcing an outright ban this spring, according to spokesman Al Heiser. But EPA officials decided to negotiate an agreement because the company could have appealed and kept the product on the market for years, he said.

FMC is the only manufacturer of carbofuran, which it sells under the trade name Furadan. It is widely used on crops in the state, particularly on corn. However, farmers have a number of alternatives, according to FMC spokesman Jeff Jacoby. The order calls for the gradual reduction of sales of the product to distributors. Distributors and farmers will face some restrictions on the sale or use of existing stocks of carbofuran.

Birds are poisoned when they mistake the granules, spread on freshly plowed fields each spring, for food. Larger birds, such as eagles, are poisoned when they eat smaller birds and animals that die of carbofuran ingestion.

The Chesapeake Bay area's bald eagle population has been recovering nicely since its dramatic decline three decades ago from DDT poisoning. DDT was banned in 1972.

The EPA estimated in 1987 that

Guest at Hyatt to get \$120,000 for needle scare

The Hyatt hotel chain has agreed to pay \$120,000 to a man who claimed a hypodermic needle popped out of his bed and stabbed him in the leg three years ago — causing him a "nightmare" of worry that he contracted the AIDS virus.

Kenneth Bressler, a New York lawyer who checked into the Hyatt Regency in downtown Baltimore, said yesterday that he was so frightened about the prospect of contracting the deadly virus that he had himself tested about six times during the two years that followed the incident.

He tested negative each time, making it highly unlikely that traces of the human immunodeficiency virus entered his bloodstream and placed him at risk for developing AIDS. But he said, "I can tell you it was a nightmare. It was incredibly stressful."

Mr. Bressler, 35, said he wanted to put the incident behind him and refused to comment further. His lawyer, Gary Strassberg, said his client sued Hyatt for "the mental anguish he and his wife suffered, particularly those first few months as a result of fearing he might have contracted AIDS."

The case was scheduled for trial yesterday in U.S. District Court in Baltimore, but Judge Marvin J. Gar-

ha dismissed the jury after learning that the case had been settled. The case was settled Friday night, according to Mr. Strassberg.

Mr. Bressler checked into the hotel during a business trip Sept. 21, 1988. When he pulled back the covers to retire for the night, his lawyer said, the action somehow dislodged a hypodermic needle that bounced out of his bed, stabbed him in the calf and fell to the floor. The needle drew a small trickle of blood.

"What he learned was that the previous night, the Hyatt staff found a number of hypodermic needles all over the room," Mr. Strassberg said. "The room was in a totally disheveled state. There was some kind of drug party going on." While cleaning the room, the staff must have overlooked a needle that lay hidden in the bed, he said.

Hyatt's lawyer, Matthew Kastanin of Rockville, could not be reached for comment.

After the incident, Mr. Bressler placed the needle in a plastic bag and returned to New York, where he submitted it to a laboratory for analysis. The lab didn't find any traces of HIV but did find particles of cocaine — a substance that is commonly used by drug dealers to cut cocaine.

Intravenous drug use is one of the most common pathways for the spread of HIV.

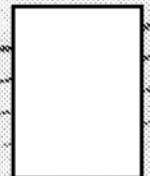

The Royal Visit of H.M. Queen Elizabeth II and H.R.H. Duke of Edinburgh

First State Visit Since the Seventies Begins in Washington Today

By Linda Shah

This morning the United States welcomes Her Majesty Queen Elizabeth II and His Royal Highness The Duke of Edinburgh. Americans may have difficulty with the protocol, figuring out which title goes with which personage, but Americans have very little difficulty recognizing the Royal Family. Most Americans look forward to the occasion — the pomp and circumstance — that will accompany the Royal Couple throughout their first State Visit to the United States since 1976.

The Queen's arrival this morning in Washington marks a juncture in relations between the United States and Great Britain that has never been closer. In virtually every aspect of the relationship, from foreign policy and trade to investment and cultural cross-fertilization, the ties have never been deeper nor the volume of interchange greater.

U.S.-British cooperation in Desert Storm was the culmination of a decade of synergy in foreign policy, and both the Queen and Prince Philip will pay personal visits to recently returned troops, view USAF and RAF demonstrations, and meet General Schwartzkopf during their stay in Texas. Doubtless their comments and private conversations will reflect the public statements made throughout the Iraq crisis and the war of the solidarity of purpose, ethics, and commitment to democracy which Americans and British alike define as the real values of the war.

In business, Britain is the number one foreign investor in the United States. At the same time, Britain is the number two location for U.S. direct investment, and has steadily closed the gap on the leader, Canada. From 1980 to 1989, U.S. manufacturing investment in the U.K. grew by a full 97 percent from \$49 billion to \$121 billion.

British or American? Whatever it is, Scotch whisky is 100 percent actually British or American. Chrysler's Jeep/Jaguar/Ford's products, such as Duracell, Vaseline and GLEPs are totally Americanized and the Minnesota company Pillsbury is ultimately owned by Grand Met, a British holding company. In Britain, the Ford is virtually a domestic car.

Although President Bush extended an invitation to the Queen several months ago, in fact at the July 1988 NATO summit, the timing could not be more appropriate. The Gulf War makes the reaffirmation that much more timely and significant. 'We stood by the U.S. right from the beginning, over the Gulf, just as you stood by us over the Falklands,'" said the Queen's spokeswoman. "State visits

City puts out carpet for queen

Washington seemingly can't get enough of royalty and the biggest name in the game arrives today: Queen Elizabeth II.

The red carpet is out for the queen and husband Prince Philip, as are all the stops. And true to Washington form, the English monarch's official visit was preceded by a month of breast-beating and back-biting over who got invited to what and who didn't rate a single "stiffy" (as the Brits call invitations).

The London Daily Telegraph reports that State Department staff are determined there must be no mishap to equal the gaffe in 1976 when President Ford whirled the queen around the White House dance floor as the band struck up "The Lady Is a Tramp."

Aside from the chance to pull on the white gloves and straw hats that Americans so rarely get to show off, the royal visit does have a serious underlying purpose: It reinforces the "special relationship" between Great Britain and the United States.

As Jocelyn Nadon of the British Embassy's information office says, "We're best friends."

To stress these ties, the queen will address a joint session of Congress — a first for an English monarch. And with Queen Elizabeth's sense of history and occasion, she'll be very pleased to do it, says Roland Flamini, author of the recently published "Sovereign."

The royal duo will be in this country for 13 days, spending four in Washington before going on to Florida and Texas, states new to the queen. Then they're off for a private weekend with the queen's horses in

the Richard England Clubhouse, a new Police Boys and Girls Club at 4103 Benning Road NE. Accompanied by first lady Barbara Bush and Mayor Sharon Pratt Dixon, the queen will tour classes and watch demonstrations of double-dutch jump roping, karate and basketball. (To ensure a warm welcome, the kids get the day off.)

Elizabeth then travels eight blocks to Drake Place, near East Capitol and 53rd streets SE, to be greeted by Housing and Urban Development Secretary Jack Kemp and see four new homes built by the Marshall Heights Community Development Organization. She'll meet the families that, for the first time, were able to buy homes. And they'll have a chance to thank her for the small housewarming gifts the British Embassy will have dropped off shortly before.

Meanwhile Philip, captain-general of the Royal Marines, heads to Quantico to watch a counter-terrorist demonstration and meet U.S. Marines who were deployed in the Persian Gulf. Given that Philip is a manly sort who often curses, in part because he thinks it makes him

Queen Elizabeth turned 65 last month, but she hasn't slowed down. She'll make 14 appearances in her four days in Washington, in an itinerary designed to get her out in front of people — both here and in Great Britain.

These tours are grueling, and the queen's staff wants her subjects (read taxpayers) back home to see just how well she does her job. So the observant will notice a cameraman and soundman dogging her every step. The team that shot the 1968 documentary "The Royal Family" were pulled out of retirement to make a second installment.

And so the rush starts.

The queen and her husband were to arrive about 10 a.m. today at An-

draws Air Force Base aboard the Concorde. She rarely takes commercial flights, though lesser Windsors do so all the time. (Which is a mixed bag for fellow travelers: Insiders say such flights inevitably are delayed because of intense security, but they're safe as can be and passengers arrive in a jolly mood since free drinks are handed out to make up for the delay.)

Today, the queen dispenses with many official obligations. From Andrews she and Philip go directly to the White House, where she and President Bush will make a few remarks before having lunch. She'll present him with the Churchill Award and plant a tree on the South Lawn.

From there, she heads to Arlington National Cemetery to place a wreath at the Tomb of the Unknowns. Then she rests for a few hours before dressing for the state dinner tonight at the White House.

The White House staff is customarily tight-lipped about preparations. But given warm relations between the nations and the fact that the president and queen are distant relatives, the East Wing staff likely is trying hard. For the queen's sake, White House watchers hope they'll muster a more lively guest list than those for some recent state dinners, when "Wheel of Fortune" host Pat Sajak was the glitziest invitee.

With official duties out of the way, tomorrow the queen mingles with the people — in her own way. That doesn't mean she'll leap out of her Rolls and press the flesh a la Gorbachev.

She'll start her day in the other Washington — a crime-ridden area nicknamed "Dodge City." First stop,

The couple then reunite to attend a luncheon for 300 at the Library of Congress, featuring dishes once served by Thomas Jefferson. Held in honor of the Festival of British Film and Television at nearby Union Station, guests will include such film luminaries as Richard and David Attenborough, Ben Kingsley, John Mills and Martin Scorsese.

Tomorrow afternoon, the queen gets to return all that hospitality in a big way. She's giving a garden party for 1,800 at the British Embassy, where a select few will be brought forward to shake her gloved hand.

After a quick spot of tea in the garden, Elizabeth and Philip head to Baltimore to catch the Orioles. Mr. Flaminio predicts this will not be a high point. The queen knows and cares little about most sports. But the game long has been sold out; a block of 300 seats was sold to Irish protesters.

If tomorrow's theme is everyday people, Thursday's must be history. The queen gets an early start, arriving at the Folger Shakespeare Library and Theatre at 10 a.m. to watch a scene from the current production of "King Lear" and see a children's play.

Then it's on to the Capitol to address the joint session of Congress, followed by lunch with House Speaker Thomas Foley.

The next stop is Mount Vernon, which the queen last visited in 1951, three months before her father died and she ascended the throne. She'll lay a wreath on George Washington's tomb and dedicate a new wharf on the Potomac before leaving by boat.

Thursday evening she is hostess again, giving a reciprocal dinner at the British Embassy. There's no doubt this is the most desirable invite of the queen's visit.

Friday morning the royal couple arrives at Washington Cathedral around 10:30 for a brief prayer service and tour. Then it's back to Andrews for a Concorde flight to Florida and more of the same.

For royal watchers, embassy staff recommend catching a glimpse of the queen at the Folger Library, the Library of Congress, Mount Vernon (where regular admission will be charged) or Washington Cathedral.

But if you'd like a dose of Merrie Olde England without standing behind a rope on a sidewalk, the Library of Congress' Mary Pickford Theater and the AMC Union Station are the sites of the fairly exhaustive British film and television festival.

Meanwhile, the Biograph in Georgetown continues with its British animation festival today and tomorrow. And through Friday, Loew's L'Enfant Plaza (where Monaco's royal family always stays while in Washington) serves tea — complete with "Di' Devonshire scones" and "Fergie's fruit tarts."

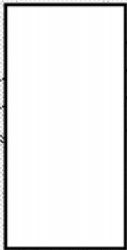
Although unconfirmed, it is believed her majesty travels with her own white kidskin toilet seat.

Queen Elizabeth's desire to see a baseball game will require a short detour out of Washington during her four-day state visit, which begins today, a Buckingham Palace spokesman said. But, he added, "the queen and Prince Philip are very happy to be going to Baltimore."

And just how much of the game will the royal couple, accompanied by their host President Bush, actually watch?

"You'll have to wait and see," said her press secretary.

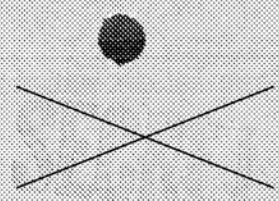

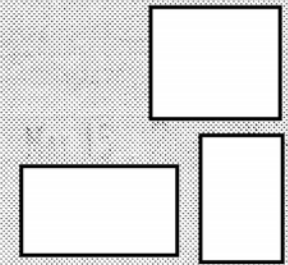
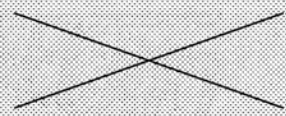

At the White House, Letting Bygones Be Bygones

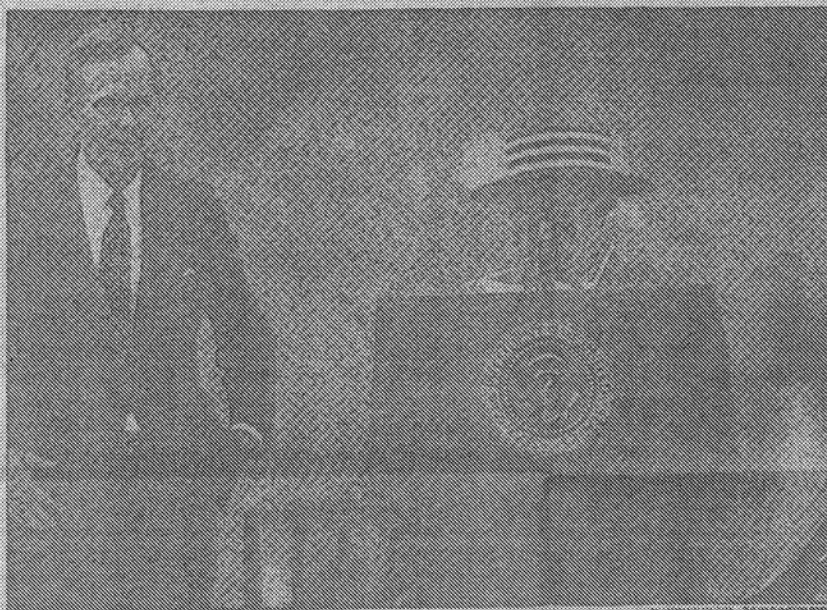
"America is lost" wrote King George III two centuries ago. But last night, making her fourth visit and her fourth toast "in the very place" where another George—her father—proposed a toast to President Roosevelt in 1939, Queen Elizabeth II let it be known that there are no hard feelings.

"No wonder I cannot feel a stranger here," she told President Bush and a stellar crowd of 130 guests at a White House dinner in her honor. "The British have never felt America to be a foreign land."

We almost weren't, President Bush noted in his toast. "I sometimes wonder if I'd be standing here today if it weren't for a horse fart that saved Paul Kenner."

She may not be our queen but any visit, state or otherwise, creates quite a stir in columns. No one else combines the aura, the majesty and the wealth of this 65-year-old grandmother. Standing at the North Entrance as the Union Jack fluttered along

And then, after the talking-hot embarrassment with the lectern on the South Lawn of the White House, everything changed.

Queen Elizabeth II, this fancy cartoon, this unpolished relic in white gloves, this corp-bitten defender of an ill-behaved faith, the walking logo for a country that looks like a theme park with rice, this highness, this majesty drove across the Potomac River, got out of her limousine at the Tomb of the Unknowns and Nature herself was estranged.

The British Press, Feasting On Tidbits

Peter McKey, correspondent for the London Evening Standard, was sipping a beer yesterday and chucking over Queen Elizabeth II's welcome at the White House, an mauspeious debut in which a thicket of microphones obscured all of the diminutive monarch except her hat.

"We're quite excited about the queen's talking hat," he said. "That's the lead for the tabloids."

"The short and tall of it is the queen was not up to the job," cracked Philip Finn, the Daily Express man, ordering another chardonnay at the Sheraton-Carlton bar.

"It's really quite extraordinary," Finn said. "After two years of very careful planning, someone forgot to bring a soapbox for her to stand on."

From the august Times of London to Rupert Murdoch's scrappy Sun, the vicars of the British press seized on the rare royal gaffe to even up what most regard as a rather ho-hum state visit. McKey was especially thrilled when Prince Philip shot him a look.

"He glared at me," McKey said. "He loathes the press. He despises what is known in London as the reptiles."

These sithering fellows even have an official nickname, the "royal rat pack." The 30 or so reporters follow the family around the globe, recording every tidbit, from the queen's practice of carrying her own drinking water on all trips to frenzied speculation about the state of Princess Diana's marriage.

"It's like feeding a monster; you can never provide enough," said Tom Corby of the British Press Association. "It's a fascination people have with the royal family—a life which to them is unattainable, unbelievably privileged. . . . You're writing contemporary history."

For the veterans who just finished last week's trip to Czechoslovakia by Prince Charles and Princess Diana, the First Couple of tabloid soap operadom, covering a 65-year-old queen is not the same cup of tea.

"Princess Di is probably one of the most beautiful women in the world," said Sun photographer Arthur Edwards, who scored some of the earliest bikini-clad shots. "Whatever she wears is a picture in itself. The queen is a bit more staid. She is formality itself."

Said Margaret Hall, a reporter for the newspaper Today: "It's going to be a tough job to get a picture of the queen on the front page—not unless her knickers fall down."

Still, Her Majesty's trip has not gone unnoticed in London.

"Queen's Arrival Puts US in a Tizz," the Independent announced. "As always, the hunt for trivia is uppermost. . . . Attention is directed where it really matters: to her 40 retainers and flunkys, to the 'up to six tons' of royal luggage, and a selection of up to 20 tiaras. . . ."

Edwards says Americans seem transfixed by the royal road show "because you don't have a family like it here. If you hadn't kicked us out 200 years ago, you'd probably have a Duchess of Dallas or a Prince of New York."

The clash of cultures is apparent in the briefing room at the Sheraton-Carlton, where impossibly handsome British spokesmen say absolutely nothing of substance, but sound terribly cultured doing so. When an American TV crew showed up for a background briefing Monday, they were quickly given the boot.

"Absolutely no pictures," explained British Embassy spokesman Michael Price. "The palace doesn't do anything on camera. It's a very different ballgame from the way you do it here. I'm afraid."

The Brits delighted in peppering the palace spokesman, who under the ground rules could not be identified, with questions about rumors that the queen would confer knighthood on Gen. Norman Schwarzkopf.

"We never comment on honors before an announcement is made," the spokesman sniffed.

"Was it her expressed wish to meet with General Schwarzkopf?"

"She is looking forward very much to meeting General Schwarzkopf." And so on.

At one end of the Fleet Street spectrum are the racy tabloids. When a security guard once briefly barred the queen from the Royal Windsor Horse Show ("I thought she was some old dear who had got lost") he found himself lambasted as a "bungler" on the Sun's front page. When Prince Charles warned that cars are polluting the Earth's environment, the Sun headline read "Charles Sends Gas Guzzling Bentley to Prague," gleefully relating how a chauffeur was dispatched 800 miles so the prince's car would be waiting in Czechoslovakia.

At the other extreme is Majesty magazine, which recently ran a photo spread on how the queen's clothes are made. "We don't write unkind pieces," says Editor Ingrid Seward. "We asked if we could write an article about the queen's fashion and she said she didn't mind as long as she could check the article herself. It came back to me with the spelling corrected."

At yesterday's briefing, the Brits were having a jolly old time as the unidentified spokesman gamely insisted that the failure to elevate the queen at the White House podium was less than an international incident. "I don't think it was anything that bothered the queen a-tall," he said.

But hadn't President Bush failed to press a button that would have produced a step for Her Majesty to stand on?

"If I were you I'd talk to the White House about any particular technology of that kind," the spokesman said.

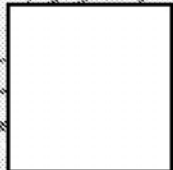

EAST RUTHERFORD, N.J., May 15—Bill Parcells, one of the most successful professional football coaches over the last eight years and a two-time Super Bowl winner, stepped down as coach of the New York Giants today.

Parcells, 49, will be replaced by Ray Handley, 46, one of his closest friends, who was promoted to offensive coordinator only three

weeks ago. Handley hinted he will retain that job.

Parcells, who in January coached the Giants to a 20-19 win over the Buffalo Bills in Super Bowl XXV, said: "What will I miss the most? On the road in Washington and on the road in [Philadelphia]. The fans there hate me so much they like me."

News of Parcells' resignation came as a surprise to most Giants players. Although rumors persisted about him leaving for a job at NBC Sports, many, including General

NFL Moves Toward Expansion

Baltimore Among Candidates for 2 Teams That May Be Added in '94

A National Football League committee chaired by Commissioner Paul Tagliabue yesterday recommended adding two teams for the 1994 season, the clearest indication yet the NFL will expand for the first time since 1976.

The recommendation of the eight-member Realignment and Expansion Committee, which met for three hours yesterday and includes the chairman of seven other owners' committees, is expected to be ratified at a two-day owners meet-

ing starting next Wednesday in Minneapolis.

Former NFL cities Baltimore and St. Louis, as well as Charlotte, N.C., are expected to be among the leading candidates for the two franchises, which are expected to cost more than \$100 million each—though a league spokesman said no price has been established. If the NFL follows past procedures, as expected, the cities will be selected first and then the ownership groups will be chosen by the current owners, said Joe Browne, a league vice president.

The two expansion cities are expected to be chosen by fall of 1992.

In baseball, the National League Expansion Committee is considering six cities—including Washington—each with its own established ownership group.

The NFL committee also recommended a realignment into six divisions of five teams each, also for the 1994 season.

Expanding in 1994 represents a one-year pushback from the timetable Tagliabue announced in January 1990 when he first spoke of his intentions to name a committee to study realignment and expansion. But 1994 is better than 1993 for

Not Fit for the Queen

Athletics Take Advantage of Errors, 6-3

BALTIMORE, May 15—The Baltimore Orioles' royal foul-ups outnumbered their majestic home runs tonight, meaning that a night for monarchs and presidents and red carpets ended with another routine defeat—this time 6-3 to the Oakland Athletics before 32,596 at Memorial Stadium.

Among those onlookers—albeit briefly—were President Bush and England's Queen Elizabeth II and Prince Philip. Had the trio remained beyond the first few innings, the queen's introduction to baseball

The Queen Is White, The Pawns Are Black

The purpose of Queen Elizabeth II's visit to Southeast Washington yesterday may have been noble, but I couldn't get past the symbolism of white royalty being whisked in to see how native blacks live.

The queen said she wanted to see the four low-income houses built by the progressive Marshall Heights Community Development Organization, and maybe she will push for similar projects once she returns to England.

But more powerful than her politics was the perception of her whiteness as the stuff of royalty, wealth and respect. To understand this, picture the audience of black children who came out to greet her, including many little girls.

They knew nothing of the royal family's

efforts—particularly Prince Charles's—to hobnob with ordinary people as an antidote to inherent aloofness.

Nor did they know that the queen is really here to thank President Bush for his role in what many blacks considered a racist war against Iraq.

All they knew was that they used to walk to school amid the lush grass and weeds that covered the vacant, trash-strewn lots in their neighborhood. Bad things happened to children in those weeds because there was no police presence to protect the youngsters.

Then, this woman arrived. She was no prettier than their mothers. No more regal and certainly no fancy dresser. In fact, she was just a plain Jane, everyday-looking woman. But for her, a police officer was stationed on every corner and metal detectors were erected in the streets.

"She doesn't even wear a crown," LaToya Johnson, 7, said.

"Or a cape," her classmate, Constance Williams, 6, said.

"Maybe she uses a magic wand like in the fairy tales," Wilma Washington, 5, said. But the other girls sensed nothing supernatural. "I doubt it," LaToya said.

As far as the girls could see, all the queen had going for her was whiteness. It was the only thing that made her different from the women to whom nobody paid much attention—their black mothers, grandmothers and aunts. Black women who live in the Marshall Heights neighborhood said they were sometimes threatened by drug dealers and verbally and physically abused. But the threats were not taken seriously.

Until the white queen arrived. "About a month ago, strange things started happening out here," said Blanche Pegram, who has lived in the neighborhood for 27 years. "Policemen on motor scooters started riding through. Then we started getting night patrols."

Many attempts had been made to get the city to cut the weeds and sweep the streets. But the city rarely took action. It took a visit from the queen to get the job done.

"They were out here every morning," said Nancy Turk, a retired teacher who lives in the neighborhood. "My street would be clean, and they'd still come by and sweep it some more."

The unprecedented activity added mightily to the queen's persona as a woman of importance. But the children had no idea what she had done to deserve it.

"You are born to be a queen," Diane Rodgers, a third grade teacher at Harris Elementary School, told some of her students. "How would you like to have someone at your beck and call?"

For those children, Queen Elizabeth was the only person they had ever seen treated this way. And deep down, they had to wonder why their mothers weren't afforded equal respect.

Their mothers worked harder than the queen, paid taxes and attended civic meetings, but still hadn't been able to get drug dealers off their streets—until this white woman came along, billed as the epitome of cleanliness because she carried her own purified water and a personalized toilet seat.

For her, the garbage was removed.

This was the kind of phenomenon, I believe, that has contributed to a startling turnabout in the way black children perceive themselves. A recent update on a famous study conducted by Kenneth Clark in the 1950s shows black girls once again preferring white dolls to black dolls.

Forty years ago, the study found, black girls wanted white dolls; but by the mid-1970s, at the height of the black-pride movement, the choice had turned to black dolls.

By the mid-1980s, the situation had reversed itself, with black girls preferring white dolls at rates surpassing the level of the 1950s.

Now came the queen, an occasion for which the little girls were scrubbed clean, outfitted in their finest clothes and taught to curtsy low and not speak until spoken to.

Better they should be taught to act like queens.

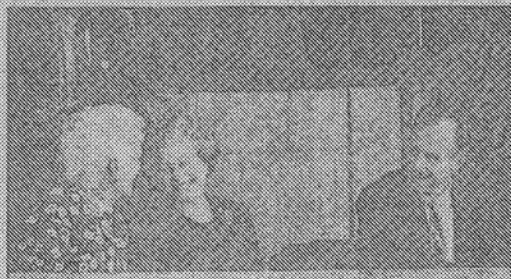

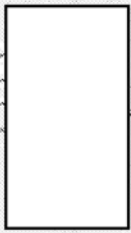

Queen, USA in a mutual embrace

From a baseball game to a bear hug, Her Majesty has a diverse Day 2

WASHINGTON — The queen got caught in a squeeze play Wednesday. And that was even before she entered Memorial Stadium in Baltimore.

While visiting a home in one of the poorer sections of the nation's capital, Queen Elizabeth II of England was royally hugged by Alice Frazier, 67. The breach of protocol — one shouldn't dare to

THINK about touching the monarch, let alone bear-hug her — didn't faze Her Majesty too greatly. She smiled weakly and quickly pulled away.

"It was beautiful," said Frazier, a retired soda fountain worker. "I hugged her a little. She didn't mind."

Royal watchers, however, were horrified. It was page 1 news in London tabloids; one referred to it as "rib-crunching." No one could recall her having been hugged before.

The monarch, accompanied by first lady Barbara Bush and Mayor Sharon Pratt Dixon, had been forewarned to expect a welcoming embrace, a Frazier custom.

"I told her this was my palace," said Frazier of her modest three-bedroom house decorated with portraits of Jell-O.

the Kennedy brothers and Martin Luther King. She wasn't upset when the queen declined chicken, potato salad and iced tea. "She didn't have time."

Her Majesty didn't get to sample Frazier's acclaimed potato salad. But she got quite a taste of American culture on the second of her 13-day tour of the states. From an inner-city neighborhood to a baseball park, from a Library of Congress luncheon stacked with stars to an embassy garden party abloom with famous faces, the queen's plate was piled high.

Everywhere she went, crowds strained for a closer look, her trip feeding the USA's continued fascination with British royalty.

The queen "has the status of somebody who is not quite real," Chicago psychologist Kate Wachs said. "She is supernatural. When we are literally able to touch her, it is like having magic visited upon the common man."

As for the queen herself, observers say she appears to be having a jolly good time.

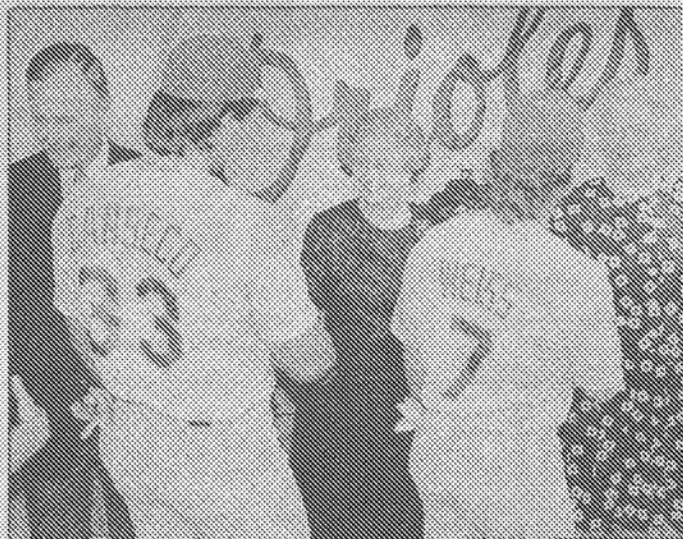
"She looks happier, more relaxed than she has recently. I think she likes the informality of the American people," noted Ingrid Seward, editor of *Majesty* magazine. A day in the life of visiting royalty:

But as she walked the red carpet, nobody seemed to mind. Cameras clicked, drums rolled, people cheered. In return, they got that queenly wave.

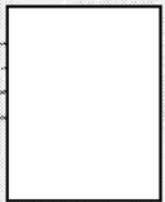

De Borchgrave
Replaced by Pruden

Arnold de Borchgrave, editor in chief of the Washington Times for the past six years, resigned yesterday with a parting shot at the cost of the press, saying that "the arrangement [media power] at times appeared to border on thought control."

De Borchgrave, 64, who for 30 years was a longtime foreign correspondent and senior editor at Newsweek, said he will take an sabbatical through the summer and then be returning to the paper's editor at large.

Managing Editor Wesley Pruden, 51, will take over the paper's editorial operation with no change in title. Deputy Managing Editor Joette Bauer, 36, a Holston Church member, will be the public-relations editor. Kirk E. Oberhelman, 46, managing editor of Knight magazine, will assume de Borchgrave's duties as top editor of that publication, which, like the Times, is owned by members and officers of the Holston Church.

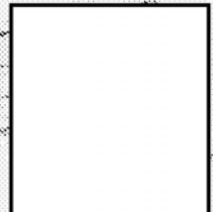

Soviet Debt, Economic Woes Grow

'Disaster' Possible, CIA Tells Congress; Loan Squeeze Looms

The Soviet Union needs \$20 billion to \$30 billion in foreign loans and credits this year, and as the country's overstated political and economic situation is making most Western banks and companies unwilling to extend it any new credit, according to International Monetary Fund officials.

The loans and credits are needed to support food and vital industrial equipment and to make payments on debts that are coming due and that Western banks and companies do not want to roll over into new loans. That's the Soviet Union's \$40 billion in commercial debt coming due within a year, according to a report by Deutsche Bank, a major lender to the country in the past, and the country's foreign exchange reserves have slipped to their lowest level in years. Moreover, other sources say the Soviet Union's arrears on trade credits have reached \$5 billion.

In Moscow yesterday, the Soviet government announced new initiatives to stem the economic slide. President Mikhail Gorbachev issued a decree lowering wages in key sectors and introducing incentives to revive lagging industrial production.

The decree, read on radio, television, and across gathering work stoppages in the energy, chemical and metallurgical industries, could face stiffer government opposition. It also gave some enterprises greater control over revenues, allowing them to retain 10 percent for their own use.

Gorbachev's decree was issued hours after Soviet Prime Minister Yegor Yevseyev announced that leaders of the Soviet Union and 13 of the country's 15 republics had

In Hill Speech, Queen Hails U.S.-British Ties

In the first address by a British monarch to the U.S. Congress, Queen Elizabeth II yesterday gave a warm, respectful response as she hailed the ties that exist between the United States and Britain and said her nation is committed to maintaining close relations between Europe and America.

Masterful in the symbolism of the moment, lawmakers, Cabinet members, military commanders and foreign diplomats stood behind and attentive as the monarch, brightly dressed, queen walked slowly into the House chamber with her husband, Prince Philip, and an escort of congressional leaders.

With only the faintest of smiles, she put them at ease from the start by passing out over the lecture from her perch on a small blue-carpeted platform supported by the House. "I do hope you can see me today just where you are," she said.

This was a polite, royal way of referring to the fact that little more than her hat was visible over microphones when she was welcomed at the White House on Tuesday, according to reports in the British press of the "talked hat."

The congressional crowd roared and gave her a standing ovation.

Without reference to the historic prescriptive conflict that separated Britain and its for-

mer colony 215 years ago, the queen spoke of the shared values of Britain and the United States, including democracy, stability and respect for what she described as the power that "comes from the barrel of a gun."

For the queen praised the U.S.-British cooperation in the Persian Gulf War, with a special " salute" to the "outstanding leadership of your president and the courage and prowess of the armed forces of the United States."

The United States and Britain viewed the long mission of Kuwait in the same way, "the courage to be reversed, both for the people of Kuwait and for the sake of the principle that ruled aggression cannot prevail," she said. "Our views were identical and so were our responses. That response was not without

Civil Rights Compromise Is Readied

House Democrats' Proposal Includes Controversial Cap

House Democratic leaders have agreed on the broad details of a compromise civil rights bill that will include a \$150,000 cap on punitive damages in discrimination cases brought by women—an idea that is offensive to some liberal Democrats and women lawmakers.

The leadership's job discrimination proposal incorporates changes agreed to in negotiations between business leaders and representatives of civil rights groups, talks that were abandoned when it became clear the White House opposed a compromise.

Democratic leaders are to unveil the bill on Monday and hope the changes favorable to business will attract enough votes from conservative Democrats and moderate Republicans to withstand an aggressive veto from President Bush. They postponed a decision on what to put the bill to a vote until they are able to ship the compromise version across the risk and the lawmakers.

The new bill will be offered as a substitute for a civil rights bill previously reported out of a House committee.

The measure is a tougher version of the anti-bias legislation vetoed last year by Bush, who claimed it would have led to the establishment of minority hiring quotas.

Last year's civil rights bill got 272 votes, 18 shy of the two-thirds necessary to overcome a presidential veto. The Senate failed to consider the veto by one vote.

risk, but we have both learned from history that we must not allow aggression to succeed."

More needs to be done, she said, alluding to allied efforts to protect Kurds and other minorities in Iraq and to achieve a broader peace in the Middle East. "If we succeed" in these efforts, "our military success will have achieved its true objective," she said.

The speech, written by British Embassy officials to reflect the views of the government now headed by Prime Minister John Major, also contained a gently worded warning against what she described as risk of "continental insularity" if Europe and America drift apart.

"Britain is at the heart of a growing movement towards greater cohesion within Europe" that is going to mean "radical economic, social and political evolution," she told the lawmakers.

Although she did not mention it, the United States is also at the heart of efforts to create another economic bloc in North America through free-trade agreements with Canada and Mexico.

"It is Britain's prime concern to ensure that the new Europe is open and liberal and that it works in growing harmony with the United States and other members of the Atlantic community," she said. "All our history in this and earlier centuries underlines the basic point that the best progress is made when Europeans and Americans act in concert. We must not allow ourselves to be enticed into a form of continental insularity."

Appearing before Congress on the third day of her visit to Washington, the queen, attired in a peach-colored dress and matching hat, was interrupted by applause seven times during her 15-minute address.

With her husband sitting in a special chair at her side, she peered almost inquisitively around the chamber before she spoke, forgoing the smiles and waves that are the trademarks of most addresses to joint meetings of the House and Senate.

Although British prime ministers—most recently Margaret Thatcher in 1985—have addressed Congress, British kings and queens have been conspicuously absent from the list of monarchs to speak on Capitol Hill.

The last was Queen Beatrix of the Netherlands in 1982.

The queen's gently regal appearance and the properly respectful response accorded her was in sharp con-

trast to the thunderous welcome that Congress gave Gen. H. Norman Schwarzkopf last week. But it provoked some controversy, especially among Irish-Americans.

Protesters opposed to British occupation of Northern Ireland demonstrated near the Capitol.

Rep. Joseph P. Kennedy II (D-Mass.) boycotted the speech, although his uncle, Sen. Edward M. Kennedy (D-Mass.), attended both the speech and a luncheon in the queen's honor afterward.

Rep. James P. Moran (D-Va.) was among several other Irish-American lawmakers who declined to attend.

Rep. Gus Savage (D-Ill.) boycotted the speech, saying the "queen of colonialism" presided over an empire "built on the exploitation of Africa and the Middle East."

Most other lawmakers appeared impressed in varying ways. It was a "very moving" appearance, said Sen. Alan K. Simpson (R-Wyo.).

"Here was a speaker you could really enjoy, knowing that nothing real heavy was going to come down," said Rep. Bill Richardson (D-N.M.).

In a comment that appeared to reflect more on Congress than the queen, Sen. J. James Exon (D-Neb.) sighed and observed, "It seems about all we do these days is go to ceremonial speeches."

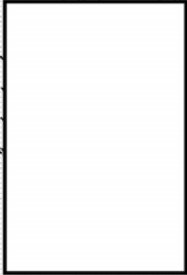

For the Queen, a Late Start On the Visit's Final Day

The queen was refreshingly late yesterday morning, to a private service at the Washington National Cathedral. Usually her car door swings grimly open as the clock's second hand sweeps perfectly, punctually into place.

But the Defender of the Faith was not on the dot. She was off by 30 minutes.

"They apologized for being late," Sanford Garner said very sweetly. He's the cathedral provost, after all. "But they did not explain why."

"Normal holdups," explained a British Embassy spokesman. "A snowtalling effect. Nothing out of the ordinary."

Lined up outside the cathedral, gaggles of tiny school kids—just 4 and 5 years old—held sweaty spring flowers picked from the Bishop's Garden while waiting to greet Queen Elizabeth II and the Duke of Edinburgh. Inside, hundreds of the cathedral's "friends and family" held to their seats.

Ushers circulated. The floors looked recently waxed. Two sparrows flew around the nave.

"We have wrens and pigeons too," said usher Julia Gaines. "They've gone through the metal detectors, so they'll be no harm to Her Majesty."

Another usher approached. They ushered themselves down memory lane . . . in 1965, when Queen Elizabeth brought the cathedral a kneeler, needlepointed by her mother . . . in 1976, when President Ford stepped on one usher's foot while walking with Queen Elizabeth down the aisle . . . in 1985, when they told people "no pictures allowed" of the Prince and Princess of Wales, just minutes before a hundred bulbs flashed anyway . . . and in 1990, when Prince Philip came to the flower mart and the Glastonbury Thorn mysteriously bloomed.

Other conversations sprang up, among worshipers. Protocol. Floor wax. The queen's travel wardrobe. This week she had already worn: melon, lemon, purple, maroon.

Bets were made.

"Turquoise," said a woman.

"Dark red," said one man.

"Noooooo," said the woman. "She's already worn maroon."

"Blue, then."

Blue it was.

Bagpipes began to play. At nearly 10:45, she greeted the children from Beauvoir School. They handed her a nosegay of pink roses. She walked down the aisle with Prince Philip, Bishop Ronald Haines, Provost Garner.

Heads stretched.

Several people stood on chairs.

Many took photographs.

The queen seemed to glide on the pale marble. Does she walk or float? In her blue flower-printed frock and white gloves and blue hat garnished with green leaves, beneath the soaring ceilings of the cathedral, lit by lamps and sunlight filtered through stained glass, embraced by an Anglican community, she seemed transcendental despite her handbag. And quite at home.

She received a gift—a book—from the cathedral. She walked past the great choir filled with choirboys and guests like John Chancellor and Chief of Protocol Joseph Reed. She sat in her own chair, next to Prince Philip's, facing the high altar. She prayed. She was blessed. She sang—"lustily," according to a cathedral source—the "Battle Hymn of the Republic."

"It's one of her favorite hymns, we're told," said the source.

Isn't it American?

"Indeed!"

On her way out, she was extremely good at walking down marble stairs. She looked at them. She looked at the congregation. She spoke only to Provost Garner.

"She seemed very interested in the cathedral itself," said Garner in his soft Tennessee accent afterward. He seemed calm. He seemed unfazed. (Perhaps after so much conversation with God, the Queen of England is easy company.)

"She was interested in the cathedral's completion, as was His Royal Highness," said Garner. "And we talked about the congregation. I explained that we tried to invite all the cathedral's friends and family. She was gracious and very pleasant, and seemed particularly happy to greet children out front. She asked about the schools here. How many there are. How many students. That sort of thing."

When Garner walked the royals outside, their motorcade wasn't lined up yet. "Even then," he recounted, "they were relaxed and very pleasant."

After the queen left the cathedral, the material world began to intervene.

Her motorcade stopped at the British Embassy, then drove to Andrews Air Force Base. Her Majesty and His Royal Highness took the Concorde to Miami (along with protocol chief Reed), where her parties and overplanned events and travel wardrobe will continue.

His new title? Only the English could have come up with it: *Honorary Knight Commander in the Military Division of the Most Honorable Order of the Bath.*

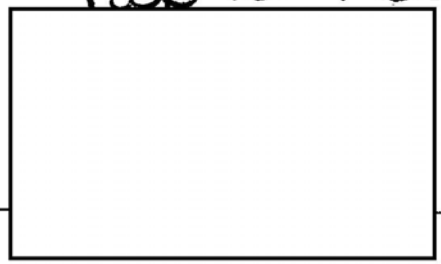

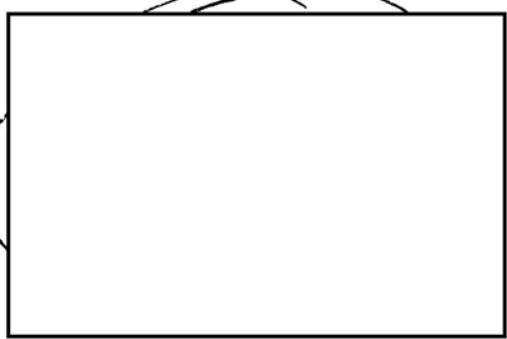

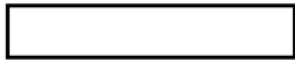
