Following a reasonable waiting period, another attempt was made to obtain this material. This search for the missing records also met with unsuccessful results.

Records which may have been responsive to your request were destroyed. Since this material could not be reviewed, it is not known if it was responsive to your request. EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;

On May 2, 1974, at 7:00 p.m., Sergeant Albuquerque Police Department, advised that the Police Department had received a call at approximately 5:00 p.m. from an unknown female caller who stated that a bomb had been placed in the Campaign Headquarters of DAVID RUSK (one of 33 mayor candidates up for election on May 7. 1974), and same was set to go off at 6:00 p.m. Sergeant related that the Albuquerque Police Department EOD Team was dispatched immediately to the scene and searched the Campaign Headquarters with negative results.

On May 3, 1974, Detective ______, Bomb Squad, Albuquerque Police Department, stated that through investigative efforts they had determined that the above mentioned caller had been a woman who works for RUSK in his mayor campaign. He advised they are conducting further investigation into this matter.

On May 2, 1974, United States Secret Service, Albuquerque, was advised of the above information.

On May 3, 1974, Assistant United States Attorney Albuquerque, was also advised of the above information.
