This is in response to your September 14, 2012 Freedom of Information Act (FOIA) request. We received your request on September 25, 2012 and assigned it case number 2012-36 for tracking purposes.

In my capacity as the Initial Denial Authority, I have determined that some of the information must be withheld from release pursuant to 5 U.S.C. § 552 (b)(6), information that if released, could reasonably be expected to constitute an unwarranted invasion of personal privacy. Due to the age of this request and turnover in personnel since it was received, these records are all that could be located by the current FOIA Office.
