Dear John Greenewald, Jr,

This letter is in reference to your Freedom of Information Act request dated 28 December 2021. We received your request and have assigned case number 2022-01246-F.

A review of the records you requested was conducted under the FOIA to determine if the documents you requested are releasable. After reviewing the documents it was determined that the documents are releasable, however, some information within the documents must be protected under the following 5 USC § 552 FOIA exemptions:

Exemption (b)(3), "Specifically exempted from disclosure by statute" IAW 10 U.S.C. § 130b. *Personnel in Overseas, Sensitive, or Routinely Deployable Units: Nondisclosure of Personally Identifying Information.* 

Exemption (b)(6), "Personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy."

The FOIA provides for the collection of fees based on the costs of processing a FOIA request and your fee category. We have placed you in the "All Other" fee category, which entitles you to get the first 2 hours of search and the first 100 pages of reproductions free. The documents we are providing you contain a total of 22 pages. There will be no duplication charges for the 22 pages.

Should you decide that an appeal to this decision is necessary, you must write to the Secretary of the Air Force within 90 calendar days from the date of this letter. Include in your appeal any reasons for reconsideration you wish to present and attach a copy of this letter. The appeal should be forwarded to:

Additionally, courts have held that the news media status "focuses on the nature of the requester, not its request.
