## **RE: Request Pursuant to the Freedom of Information Act – FOIA #19-032**

Dear Mr. Greenewald:

This letter is in response to your undated Freedom of Information Act (FOIA) request to the U.S. Agency for Global Media (USAGM)/Broadcasting Board of Governors (BBG), which the Agency received on March 1, 2019. In your request, you seek an electronic copy of the Agency's FOIA Case, FOIA Appeals, and Mandatory Declassification Review (MDR) Logs for the 2018 calendar year. Additionally, you ask that the logs include the case number, date submitted, date closed, requester's name, and subject of the request.
