Dear Mr. Greenewald:

This is the final response to your June 2, 2017 Freedom of Information Act (FOIA) request to the United States Agency for International Development (USAID). You requested the entire Mandatory Declassification Review (MDR) log for all years available.

For your information, Congress excluded three (3) discrete categories of law enforcement and national security records from the FOIA. See 5 U.S.C§ 552(c) (2006 & Supp. IV (2010)). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all of our requesters and should not be construed as an indication that excluded records do, or do not, exist.

USAID conducted a comprehensive search of the Bureau for Management, Office of Management Services, Information and Records Division (M/MS/IRD). The search produced a total of three pages. Of those pages, we have determined that three pages are releasable in their entirety.
