Re: Freedom of Information Act Request: Tracking Number DNFSB FY 19-10

Dear Mr. Greenewald:

This letter responds to the Freedom of Information Act request you submitted to the Defense Nuclear Facilities Safety Board via the National FOIA Portal by e-mail dated April 18, 2019. In that request, which was assigned the DNFSB tracking number FY 19-10, you asked for copies of the agency's FOIA case log, FOIA Appeals Log, and Mandatory Declassification Review log for either calendar years or fiscal years 2007 through 2017.

With regard to the first part of your request, you can find the FOIA case logs for fiscal years 2008 through 2015 on the agency's FOIA web page at https://www.dnfsb.gov/sites/default/files/page/FOIA Case Log 2008-2015.pdf. A copy of the log for fiscal years 2016 – 2017, which contains redactions made pursuant to FOIA Exemption 6, is attached to this letter. The records for 2007 are no longer available. The DNFSB maintains its FOIA records in accordance with General Records Schedule 4.2, which provides for the destruction of FOIA after the longer of six years following final agency action or 3 years after final adjudication by the courts, both of which deadlines have long since passed.

FOIA Exemption 6 applies to "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy...." 5 U.S.C. § 552(b)(6). The phrase "similar files" covers any agency records containing information about a particular individual that can be identified as applying to that individual. See, United States Dep't of State v. Washington Post Co., 456 U.S. 595, 602 (1982). To determine whether releasing records containing information about a particular individual would constitute a clearly unwarranted invasion of personal privacy, we are required to balance the individual privacy interests that would be affected by disclosure against the public interest in the information (viewed in terms of the insight it would provide into the activities of the government). See United States Dep't of Justice v. Reporters Comm. for Freedom of Press, 489 U.S. 749, 773-75 (1989).

We have redacted the names of individuals who are the subject of requests for personal information and other information that could be useful in identifying that individual. Those individuals have a substantial privacy interest in protecting their identities from public release, and you have not proffered any countervailing information as to a public interest in the

information that is recognizable under the FOIA. We have determined, therefore, that disclosing the information would shed little or no light on governmental operations whereas the individuals to whom it pertains have a substantial privacy interest in protecting it.

There are no records that are responsive to your request for Mandatory Declassification Review logs or for FOIA appeal logs.

You have the right to file an administrative appeal within ninety (90) days of your receipt of this letter. Your appeal must be in writing, be clearly marked with the words, "Freedom of Information Act Appeal," and be addressed as follows:
