Dear Mr. Greenewald:

This responds to your Freedom of Information Act (FOIA) request of February 28, 2019, requesting a copy of FOIA Case Log, FOIA Appeals Log and Mandatory Declassification Review (MDR) Log for calendar year 2018. This request was received in our office on March 1, 2019.

We have completed a review of the records and determined that the information is partially releasable.

Information has been sanitized as the release of the information would result in an unwarranted invasion of the privacy rights of the individuals concerned, this information is exempt from public disclosure provisions of the FOIA pursuant to Title 5 U.S. Code 552 (b)(6).

The withholding of the information described above is a partial denial of your request. This denial is made on behalf of Major General Gary W. Johnson, the Commanding General U.S. Army Intelligence and Security Command, who is the Initial Denial Authority for Army intelligence investigative and security records under the FOIA. You have the right to appeal this decision to the Secretary of the Army. Your appeal must be postmarked no later than 90 calendar days from the date of this letter. After the 90-day period, the case may be considered closed; however, such closure does not preclude you from filing litigation in the courts. You should state the basis of your disagreement with the response and provide justification for a reconsideration of the denial. An appeal may not serve as a request for additional or new information. An appeal may only address information denied in this response. Your appeal is to be made to this office, for forwarding, as appropriate to the Secretary of the Army, Office of the General Counsel.
