CONGRESSIONAL OUTREACH

- lack said that all the outreach postenday to Congresswoman Lowey seems to have had a positive impact. She still is not comfortable with the Pakistan energy reprogramming because she fears it will turn out to be a much bigger project, but apparently will not object to the immediate request for reprogramming.
- Jack noted the need for more outreach to Congressman Obey, adding that he is using the Vietnam analogy to refer to the situation in Afghanistan more and more. Anne-Marie said that this is becoming much more widespread among Democrats on the Hill, pointing especially to Senator Kerry.
- Rich raised the idea of an S call to Senator Leany to flag our concerns about cuts to food security, Pakistan FMF and Merida assistance to Mexico. Jack suggested we needed to get our priorities straight, and that he would personally press hardest on Pak FMF and Mexico. Rich said he had a 9:30 call in to Nisha Desai on Lowey's staff and that this might clarify where things stand.
- Jack questioned whether he should call Congressman Obey to discuss assistance to Palau, noting that Secretary Salazar has aready weighed in. Rich agreed, but said Dan Fried is very concerned about the signal that will be sent to countries thinking of taking detainees from GTMO if assistance to Palau is cut.
- Rich renormed that the Secretary's Hill briefings on refugees had gone well yesterday, and that she made progress with Senator Schumer on pressing for a resolution of the New York property issue and the opening of a brace General Halson office.

Sheba noted that uim had concerns about our press guidance on Goldstone, noting that we are schizophrenic when it comes to the Euman Rights Council mandate. On the one hand, we criticize the mandate, but on the other hand, we insist that the mandate requires the report be kept in the HRC. The best thing is to not due the mandate as the reason for keeping the discussion in the HRC; instead, we should just dote that we favor keeping the discussion there and leave it at that.
