agreed to in the Tegucigalpa-San Jose Accord, including the formation of a government of unity and national reconciliation and the December 2 congressional vote on President Zelaya"s restitution. These are vital elements of the Tegucigalpa-San Jose Accord, and the Honduran people and the international community expect an expeditious determination. We look forward to the Congressional deliberations getting underway as announced.

The November 29 national elections are another critical step in the restoration of the democratic and constitutional order in Honduras. The electoral process -- launched well before June 28 and involving legitimate candidates representing parties with longstanding democratic traditions from a broad ideological spectrum -- is conducted under the stewardship of the non-partisan Supreme Electoral Tribunal, which was also selected before the coup. The electoral renewal of presidential, congressional and mayoral mandates, enshrined in the Honduran constitution, is an inalienable expression of the sovereign will of the citizens of Honduras. We wish the Honduran people well as they choose their new leaders on Sunday, and we urge all sides to exercise their rights peacefully.

The holding of a free, fair and transparent election is necessary but not sufficient for Honduras to reestablish the democratic and constitutional order. In order to help achieve that objective, we will continue, along with others in the region, to support the step-by-step implementation of the Tegucigalpa-San Jose Accord as a democratic way forward for
