Today's SS on CDI is a "landmark victory" for the good guys. This is not just media talk---- Our REAL hope is the reporting mechanism will translate into impact on the ground and that SS will have "preventative" effect- ie notice that there will be accountability for HRts abuses.

Getting the Council to act in real time on a real HRts crisis is a big deal for the institution. Before anyone rolls their eyes and says- "institution" is not important concern.....the only way the HRC can have ANY effect on HRTs is if it is a credible institution and develops mechanisms that have impact.
