Jeff/Jake,

The air carriers from whom we have leased the evacuation aircraft put in the normal landing clearance requests to the head of the Egyptian CAA, name below. He has not granted landing clearance. Our push to begin the evacuation would be aborted if this can't be fixed soon.

We are trying at all levels to get the landing clearances. Matt Tueller has tried but has not had any results so far.

M said that he would have to ask the Secretary to make a call if this can't get resolved quickly. He suggested you might make a direct call to the Foreign Minister and if it would be useful, the Egyptian Ambassador.

Attached is the list of aircraft that are scheduled to arrive in Cairo tomorrow morning.
