Former Congressman Curt Wheidon who recently visited Libya called me to say that he and Congressman Galegly of HFAC (vice Chair) were on a conference call with Saadi Qadhafi, son of the leader. Wheldon said he was maintaining contact with Saadi to try to get the 4 journalists released and to get

out of the country. Saadi was very positive that the journalists would be released very soon. He was taking a personal interest in seeing that Ms. Gillis had her own laptop and was going to be moved to a hotel. He acknowledged he is up against hardliners (including Saif el-islam) who are arguing what will they get if the journalists are released. Saadi promised to call Wheldon back in a few hours hopefully with good news.

Wheldon told me he and Galegly are willing to travel again to Tripoli to give the firm message to Qadhafi if the administration believes that would be useful.
